2018-2019 School System Planning

Like in previous years, the 2018-2019 school system planning process helps school systems create strong academic plans for the upcoming school year. The school system planning process involves the following steps:



Planning for Struggling Schools

Unlike in previous years, the new ESSA law requires school systems to develop plans for struggling schools and submit those plans to the state.

The Department has supported school systems in creating these plans by:

- Hosting a School Redesign Summit
- Issuing planning grants
- Providing ongoing support from networks

School systems with schools on Louisiana's Comprehensive Intervention Schools list submitted plans for these schools at either the September 29 or March 1 deadline.

Implementation Support


Moving forward, the Department will provide support to school systems with approved redesign plans in three phases. School system supervisors will learn more about these phases of support at the [March Supervisor Collaborations](#).

Support	Role
Pre-Implementation	Ensure that all materials and calendars are in place for the start of the new school year
Early Review	Classroom observations to determine what additional support and professional development teachers need to help them use their curriculum effectively
Deep Support	Concentrated and comprehensive support from a third-party vendor for school systems who need additional help with implementation

Early Childhood

Early Childhood Updates

Early Childhood Community Network Lead Agencies:

- Designations for current Early Childhood Community Network Lead Agencies expire June 30.
- The Department will post a Request for Applications for Early Childhood Community Network Lead Agencies during the month of April.
- Early Childhood Lead Agencies will be selected for the period July 1, 2018 through June 30, 2020.
- Applications will be evaluated in early May and recommendations will be referred to BESE for approval in June.

Additional Improvement Funding for Selected Preschool Expansion Grant (PEG) Communities:

- This winter, PEG communities had the opportunity to apply for additional funds to support Approaching Proficient and Unsatisfactory sites through newly-allocated PEG funds.
- A number of communities have been selected based on their innovative proposals for improving their most at-risk sites, these funds will be allocated by BESE in March.


Child Care Criminal Background Checks

Louisiana must implement a comprehensive criminal background check system for child care centers in order to comply with the requirements in the Child Care Development Block Grant (CCDBG) Act.

The new Child Care Criminal Background Check (CCCBC) differs from the previously required background checks in both substance and in process.

- This will be required for all individuals who work with Louisiana's child care centers, including any school system staff, coaches, and other service providers.
- There are additional registries and lists (both national and state) that are required to be included.
- The Department has been engaging with providers and others affected through road shows, webinars, publishing resources, and providing training. More information can be found [here](#).
- The new CCCBC is required of new hires starting March 1. There will be a transition period for existing staff to get a CCCBC between March 1 and September 30.
- Beginning September 30, child care centers may receive deficiencies for having outdated CCCBCs.
- This is a critical change for all individuals working with Louisiana's child care centers.

Professional Development: Mentor Teachers and Content Leaders

Mentor Teachers and Content Leaders can play an important role in schools' and school systems' plans to provide ongoing, school-based, pedagogical-specific training to teachers while also creating a leadership pipeline for top talent.

Content Leaders can help provide content-rich and curriculum-specific professional development for teachers.

Mentor Teachers coach residents in undergraduate and post-baccalaureate teacher programs through various avenues, including co-teaching, and also support developing teachers.

Both Mentor Teachers and Content Leaders attend in-person trainings and receive access to turnkey training materials that build content knowledge and strengthen their ability to support adult learners.

Instructional Support: Aligning to the Special Education Strategies

The Department is committed to ensuring that all students, including students with disabilities, have access to high-quality instruction every day.

In September, the Department released a [Guidebook for Supporting Students with Disabilities](#). The Guidebook identifies four specific strategies for improving outcomes and achievement of students with disabilities. These strategies are reflected in the rubric for School Redesign.

- Identify disabilities early and accurately
- Provide high-quality instruction to ensure the achievement of ambitious IEP goals
- Strengthen instruction with specialized supports and related services
- Coordinate effective transition planning and implementation

To further support school systems in implementing the four strategies, the Department will introduce a strategy-based planning template at the [March Supervisors' Collaboratives](#). The template is designed to assist school systems in developing plans for their Special Education programs in the 2018-2019 school year.

Instructional Support: Aligning Special Education Plans and Funding

In completing the Special Education planning process, school systems will be prompted to define plans for key activities within each of the four strategies as well as within Program Administration and Support and Coordinated Early Intervening Services (CEIS).

Following this planning process, school systems should align budgets to make strategic use of all funding sources to support development and implementation of their plans.

Note: This planning process will not impact the amount of a school system's IDEA allocation.

To support school systems in directing IDEA funds to support their plans, the structure of the 2018-2019 IDEA Consolidated Application will reflect this strategy-based planning process.

Throughout Spring 2018, the Department will provide multiple opportunities for support to assist school systems in navigating these shifts.

As schools and students begin their final preparations for the spring Louisiana Educational Assessment Program (LEAP 2025) tests, the Louisiana Department of Education (LDE) created this fact sheet to provide parents with general information about the tests, and what you and your child can expect when he or she takes the tests in April and May.



KNOW THE TEST

LEAP 2025 TESTS

Each year, students in grades 3 through high school take state tests to measure their knowledge and skills in each subject area and their readiness for the next level of study.

The LEAP 2025 tests are just one of several indicators, in combination with report cards, teacher-made tests, and classroom work, that are used to create a complete picture of a student's performance in school. The results from the tests will be used to help teachers identify when students need additional support or more challenging work in each subject area. This information is also used to measure how well schools and school systems are helping students achieve higher expectations.

Students with the most significant learning disabilities are eligible to take the LEAP Alternate Assessment, Level 1 (LAAlt) for Science in grades 4, 8, and 11 and LEAP Connect in grades 3-8 in ELA and Math. LEAP Connect is given to students from February 5 through March 16, depending on schools' individual schedules.

SCIENCE FIELD TEST

In order to update the LEAP 2025 science test to the new Louisiana Science Standards, all students this spring will participate in a field test. Students will not receive a score report for their performance on the field test, but the results will be used to design the test that students will take next year.



TEST SCHEDULES

LEAP 2025 TEST SCHEDULE

Students in grades 5 through high school will take the LEAP 2025 tests in ELA, math, and social studies online. Students will also participate in a science field test, in grades 3-8. Schools have the option to test students in grades 3 and 4 online or on paper.

All LEAP 2025 tests are strictly timed, and no additional time is permitted except for students who have a documented extended time accommodation.

Schools have the discretion to determine the schedule for administering the online tests below. Therefore, testing days and session rotation will vary by school.

Technology Support



2017 Cohort Graduation Data Certification

- Each year, the Department provides school systems with an opportunity to review the data that are used to calculate school performance scores.
- In March, the first of three data certification periods will be conducted to allow school systems a review of cohort graduation data certification rosters and to request changes/corrections that can be documented.
- Accountability contacts will receive an email to announce the opening date. The email will include their user ID, password, and important resources that will guide them through the process of submitting changes in Louisiana Data Review.


This will be the final opportunity to review data before the 2017 graduation rate is calculated. It is very important that accountability contact information is up to date.

Data Systems: End-Of-Year Collections

Beginning in March, data managers will begin submitting data to the Department to close out the school year:

- During the school year, school systems submit planned calendars. Final school calendars will include all changes such as makeup days for emergency closures.
- Final student data (e.g. enrollment, attendance, discipline, free/reduced lunch) will be used for reporting and funding adjustments (if applicable).
- Parental Consent updates and transcripts/final grades submitted for students in grades T9 through 12 will be used by the Board Of Regents for post-secondary eligibility, financial award determinations and by LOSFA for TOPS scholarship eligibility.

The Department is preparing for the second year of LEAP 360 implementation. School systems that signed a LEAP 360 Memorandum of Understanding (MOU) for the 2017-2018 school year may choose to continue using LEAP 360 through June 30, 2019, under the same terms and conditions.

LEAP 360 will be available to districts in the 2018-2019 at no cost.

Year two provides school systems with an opportunity to:

- re-evaluate existing practices,
- reduce duplicative testing, and
- transition to a more comprehensive assessment system that yields valid and reliable information on student performance throughout the school year.



The 2017-2018 educator workforce data will be released on the secure site in March. This information will enable school and school system leaders to make critical decisions around the following areas:

- 4) Evaluating results
