

Unifying Louisiana's Early Childhood System

Louisiana's fragmented early childhood system led to Act 3 (2012), which calls for a unified system to ensure all children enter kindergarten ready.



Early Childhood Unification: 3 Years of Learnings from Field


Local communities continue to lead Act 3 implementation.

Community Network:

- All parishes have a local network that includes all publicly-funded programs (child care, Head Start, PreK)
- Networks are building collaborative leadership, supporting teachers and coordinating enrollment

2015-2016 is a Learning Year for Networks and Programs:

- Every classroom will be observed twice with CLASS and receive feedback
- Teachers are being supported through training and coaching to improve interactions and to use tools like curriculum and assessment
- All programs and networks will receive a practice performance profile



As part of multi-year transition, LDE became CCDF Lead Agency on July 1:

- New licensing regulations went into effect
- Child Care Assistance Program Eligibility moved to the LDE
- Quality Start is transitioning to new unified rating and improvement system
- Child care support resources are being aligned to build Pathway to Improvement



Child Care Pathway to Improvement

CCDF Quality Funds help provide aligned supports for child care programs

Foundational Training
Every program received free training on Standards, GOLD and CLASS

CLASS Observations and Feedback
Every classroom receives CLASS observations and results 2x a year

Aligned Supports

*Every program has access to guidance on creating a comprehensive plan **and** quality supports that have been vetted and address their individualized needs*

(Resource & Referral, Head Start, School District, LDE-provided)

Coaching/Technical Assistance

Background on the State Plan

State Plan outlines how CCDF funds will be used to provide access to and improve the quality of child care in Louisiana.

What is a CCDF State Plan?

- Primary mechanism by which the federal Administration of Children and Families (ACF) determines State compliance with requirements of the Child Care and Development Block Grant Act of 2014
- Every state is currently completing a State Plan

What time period does the State Plan cover?

- Covers June 1, 2016 – September 30, 2018
- Revisions may be made at any time

What is the role of the Advisory Council?

- Advisory Council shall receive and have opportunity to make recommendations on plan and/or revisions prior to submission to ACF
- Recommendations made by the council shall be reported to the state board



Highlights of the New Law

New law includes multiple changes in how states oversee and administer child care assistance, licensing and quality improvement.

What are the most significant changes required by the new law?

- Higher health and safety standards for all types of child care providers including criminal background checks, group size requirements, and more monitoring requirements.
- Families must be able to easily access important health and safety information about providers, including via website
- CCAP eligibility determinations must be for at least 12 months, even if work or school status changes, and there must be a gradual phase out once families are no longer eligible
- CCAP policies must promote access for homeless families
- Set-aside threshold for quality improvement is higher, with expectations for supporting infants and toddlers, establishing learning and development standards and enhancing professional development

Process for Developing Louisiana's State Plan

State must consult with multiple stakeholders in planning process.

What is the process and timeline for producing the State Plan?

1. Share draft plan with stakeholders and offer survey for feedback
 - *Release – December 18, 2015*
 - *Webinar – January 13, 2016*
 - *Suggested deadline for feedback – January 22, 2016*
 - *Final deadline for feedback – February 5, 2016*
2. Conduct Public Hearing – February 4, 2016 in the morning
3. Share with Early Childhood Advisory Council – February 4, 2016 in the afternoon
4. Submit Final Plan – March 1, 2016

Areas Covered by the State Plan

State Plan uses set template that covers 8 areas.

1. Define CCDF Leadership and Coordination with Relevant Systems
2. Promote Family Engagement through Outreach and Consumer Education
3. Provide Stable Child Care Financial Assistance to Families
4. Ensure Equal Access to High Quality Child Care for Low-Income Children
5. Establish Standards and Monitoring Processes to Ensure the Health and Safety of Children in Child Care Settings
6. Recruit and Retain a Qualified and Effective Child Care Workforce
7. Support Continuous Quality Improvement
8. Ensure Grantee Program Integrity and Accountability

State Plan Section by Section: 1 and 2

- **Section 1 - Define CCDF Leadership and Coordination with Relevant Systems**
 - Identifies the Department of Education as CCDF Lead Agency
 - Details State Plan process, including extensive consultation with stakeholders
 - Describes how the Department will work with public and private partners at state and local level, highlighting the new state Early Childhood Advisory Council and local coordination efforts of Early Childhood Community Networks
 - Outlines timeline and approach for developing disaster and emergency preparedness plans for child care

- **Section 2 - Promote Family Engagement through Outreach and Consumer Education**
 - Highlights coordinated enrollment, specifically how the efforts of local Community Networks are making it easier for families to apply and enroll in child care
 - Describes how the Department will use its website to provide families with information about program health and safety (licensing) and program quality (performance profiles) as well as referrals for other key resources such as food, healthcare and public assistance
 - Includes plan for how the Department will work with partners to increase referrals for developmental screening

State Plan Section by Section: 3 and 4

➤ **Section 3 - Provide Stable Child Care Financial Assistance to Families**

- Provides extensive detail about eligibility policy and procedures for Child Care Assistance Program (CCAP)
- Highlights new policy for providing at least 12 months of CCAP eligibility, regardless of changes to work or school status, and reducing co-payments
- Includes plan for making adjustments based on income and providing gradual phase out of the program for families that are no longer CCAP eligible
- Describes strategies for ensuring access and quality care for the most vulnerable families, including very low income families, families needing protective services and families experiencing homelessness

➤ **Section 4 - Ensure Equal Access to High Quality Child Care for Low-Income Children**

- Describes how the Department will provide information via performance profiles and oversee local coordinated enrollment to ensure families have equal access to choose the program that best meets the needs of their children
- Highlights the use of the Market Rate Survey and Early Childhood Funding Model to inform policy and ensure access
- Details the CCAP payment rates, tiered bonus system and payment procedures, including recent increases to support improvements in interaction and instruction quality

State Plan Section by Section: 5 and 6

- **Section 5 - Establish Standards and Monitoring Processes to Ensure the Health and Safety of Child Care Settings**
 - Provides comprehensive detail about licensing, health and safety standards for licensed and registered providers, including ratios, training and monitoring
 - Describes employment criteria for licensing specialists and plan for establishing standards for ratio of specialists to providers
 - Identifies plan and timeline for including group size and strengthening criminal background checks in licensing and registration laws and regulations.

- **Section 6 - Recruit and Retain a Qualified and Effective Child Care Workforce**
 - Describes Louisiana's professional development system, including the trainer approval process, professional registry, articulation agreements and supports for teachers to pursue credentials and continuing education
 - Explains role of Child Care Support Organizations in providing high-quality professional development aligned with the new rating and improvement system
 - Details recent cross-sector efforts to align on teacher competencies, articulation and preparation as part of building a Birth to Kindergarten Professional Pathway
 - Highlights Louisiana's new Early Childhood Ancillary Teaching Certificate, the requirement for all publicly-funded teachers to obtain this credential and resources to support teachers to do so such as *Believe and Prepare*

State Plan Section by Section: 7 and 8

➤ **Section 7 - Support Continuous Quality Improvement**

- Explains how funds will be used to support child care improvement including:
 - *Implementing a new unified rating and improvement system with performance profiles for programs and networks*
 - *Funding Child Care Support Organizations to provide training and technical assistance*
 - *Funding Mental Health Consultation to offer in-depth coaching and technical assistance to child care providers*
 - *Funding Pathways, scholarships and Believe and Prepare to prepare child care teachers to be successful in Louisiana classrooms*
 - *Supporting School Readiness Tax Credits to incent providers to make improvements and families to choose quality*
 - *Providing specific set-asides to support teachers of infants and toddlers*

➤ **Section 8 - Ensure Grantee Program Integrity and Accountability**

- Describes Department practices to ensure program integrity and to identify fraud or other program violations, recognizing that significant programmatic changes such as changes to eligibility policy are being implemented
- Details how the Department will train staff on new policies and procedures, oversee contractors and address fraud, administrative error and auditing

Keep CCAP funding levels the same during the summer	<ul style="list-style-type: none">• The LDE will keep the rates the same year round.
Improve communications and application process for CCAP eligibility	<ul style="list-style-type: none">• Transition has been challenging and customer service needs to improve• Increasing CCAP funding, which took effect February 1, should help address 7+ years of declining applications and enrollment• Rejection rates are comparable to those in recent years
New required Criminal Background Checks (CBC) are too onerous	<ul style="list-style-type: none">• Changes are due to new federal requirements• The LDE will work with state police to simplify process to the greatest extent feasible
Phase out period is too short	<ul style="list-style-type: none">• Additional guidance from Feds is needed before policy changes are made

State must submit the Final Plan by March 1 2016.



- 7 year decline in CCAP participation continues at comparable rate


Average CCAP Children per Month
