It establishes the core knowledge required of any cybersecurity role and provides a springboard to intermediate-level cybersecurity jobs. Security+ incorporates best practices in hands-on trouble-shooting to ensure security professionals have practical security problem-solving skills. Students must pass the SYO-501 exam composed of 90 multiple choice and performance-based questions. Exams are 90 minutes in length and a passing score is 750 (on a scale of 100 – 900). Exams are administered at Pearson Vue Authorized Testing Centers. Schools can become authorized testing centers through CompTIA Academy Partners. Request information: academy@comptia.org . Instructor Certification Requirements (by certifying agency)	CompTIA Security+ teacher certification required. Instructors may be interested in joining the CompTIA Instructor Network .					
Proctoring / Test Security (if any)	CompTIA exams are administered under secure, proctored conditions at Authorized Prometric and Pearson VUE testing centers. Prometric and Pearson VUE confirm the identity of exam candidates and provide a controlled environment for collecting and transmitting exam results. Credentialing Documentation	CompTIA Security + maintains all documentation. Students create their own CompTIA Certification account and can track CompTIA Security+ certification (and other certifications offered by CompTIA) online.
