

DATA IMPACTED BY COMMUNITY ELIGIBILITY PROVISION (CEP)

What is CEP?	USDA program made available to all states beginning July 1, 2014 that allows schools to offer breakfast and lunch at no charge to all students.		
Benefits?	All kids eat free.		

What are the implications? Paper applications will no longer be used to determine eligibility for meal services in participating schools.

Since free and reduced lunch information, derived from the traditional applications and direct certification, was previously used for many other programs (see below), LDE will use proxy measures for these programs.
