

## **AFR 70% Evaluation Allocation Process for General Fund Current Expenditures**

The following pages depict how AFR data is applied in the evaluation.

- Determination of instructional-related vs. non-instructional expenditures is based on the functional areas in which expended;
- Allocation of expenditures between school and non-school locations depend heavily upon percentages developed from PEP and SIS submissions; i.e., staff salaries, FTE, and student counts.
- Data used are 2017-18 general fund entries from the basic AFR report (project code AA0)
