

Apply for the Excellence in Authorizing Fellowship online.

The Excellence in Authorizing Fellowship was developed to build the individual and collective capacities of school systems in Louisiana to authorize using best practices. In conjunction with the Louisiana Department of Education, The National Association of Charter School Authorizers (NACSA) will provide fellows with resources, professional development, and collaboration opportunities targeting charter school authorizing. Throughout the year-long fellowship, fellows will attend a series of hybrid courses aimed to enhance the expertise of local authorizers and introduce national best practices in charter school authorizing. Fellows who complete the targeted professional development will be recognized during the June BESE Meeting. The second cohort will run in 2023-2024.

Frequently Asked Questions

What is the Excellence in Authorizing Fellowship?

Using ESSER I and ESSER II Funds, the Louisiana Department of Education, in conjunction with the <u>National Association of Charter School Authorizers (NACSA)</u>, will provide resources, professional development, and collaboration opportunities to promote best practices in authorizing to fellows from local education systems throughout the year-long fellowship.

How do I benefit from being a fellow?

This hybrid fellowship was designed to strengthen the State's charter school sector by advancing the authorizing profession and building a cohort of authorizing leaders. Authorizers decide who can start a new charter school, set academic and operational expectations, and oversee school performance. They also decide whether a charter should remain open or close at the end of its contract.

Who can participate?

The Department will select up to 10 fellows who currently serve as district personnel, an Assistant Superintendent, or Superintendent to grow their knowledge of the charter authorization process.

How are fellows selected?

Interested fellows will participate in a competitive selection process. The first round will include an application and approval from your immediate supervisor. The second round will include a Zoom interview with the selection committee.

Will there be another cohort of fellows in the future?

Cohort One will run from February 2023 to June 2023. Cohort Two will run from August 2023 to June 2024. Cohort Three will run from August 2024 to June 2025.

What is the time commitment to participate in the Excellence in Authorizing Fellowship?

Monthly cycles of learning includes two in-person day long training sessions, four asynchronous modules, and four virtual synchronous sessions. All day-long sessions will take place in Baton Rouge.
