Throughout the 2020-21, 2021-2022, and 2022-2023 school years, our attendance data continues to indicate that a substantial number of students from all subgroups at a rate relatively similar to our total subgroup enrollment have been significantly impacted by the COVID-19 pandemic. Therefore, we have utilized an outcomes-based decision-making rubric based on principles of universal implementation and consistent access of key initiatives, with attention paid to specific outcomes for students performing below mastery on state assessments. This means we have allocated our funding to ensure that all students at all school sites are impacted by our ongoing teacher professional development and high-quality curriculum implementation. Empowering our principals and ILTs to identify those students scoring below mastery who may benefit from additional interventions and supports, we provide literacy interventions and extensions at appropriate rates based on this analysis. Further, our focus is on removing barriers to accessing programming and services for students and families identified through these processes as having the most acute needs.

East Feliciana Public Schools shall provide expanded academic support for students performing below mastery in ELA and math through the use of high-quality instructional materials and practices that are fully aligned with the Tier 1 curricula being implemented in all classrooms. Specifically, we will utilize the supplementary instructional materials from Zearn, Eureka, Guidebooks, mClass intervention, and Lexia PowerUp to provide small-group instruction either through an interventionist or from the classroom teacher in a block beyond the core Tier I instructional time. All schools have designed their instructional schedules to ensure that time during the school day is provided for these acceleration interventions while we continue to focus on ensuring that our core instruction remains on an appropriate year-long pace through ongoing district- and school-level curriculum implementation walkthroughs. We will monitor the efficacy of these interventions both through the embedded assessments within these instructional tools as well as student performance on LEAP 360 interim assessments. This will allow us to determine how well these students are progressing towards Mastery on the LEAP 2025 assessments.

We will also continue to pilot Eureka Math Squared resources in areas where we have identified teacher readiness. We will monitor the efficacy of this at the classroom, school, and district level through analysis of weekly, unit, and interim assessments in order to identify just-in-time supports that may benefit students.

# Describe how the LEA is upgrading and/or ensuring proper cybersecurity and system upgrades are being implemented/planned.

Our focus in data infrastructure and cyber security has been in improving our physical capital, our software and hardware capabilities, and the cybersecurity awareness of all staff members. To ensure that we are engaging in best practices in these areas, we are contracting with an external IT service provider that works with several other LEAs. They have assisted us in upgrading our physical network infrastructure, improving and streamlining network access in a way that enhances security, and supporting us to provide additional cybersecurity training to all employees, particularly related to anti-Phishing. We also continue to actively participate in calls and webinars related to cybersecurity that are called by the Louisiana State Police and other entities to ensure that we are executing best practices in the light of emerging threats. We have also shifted to Linewize as our vendor for web filtering, as their product allows us more flexibility and clearer reporting in monitoring what is occurring on network devices so that our school-based and district-based staff are able to take more immediate action regarding any potential threats.
