Each upgrade implementation is carefully planned and methodically implemented to ensure business continuity and a smooth transition while minimizing operational impact and ensuring cybersecurity is not compromised. Core switching is central to all upgrades and is implemented first, followed by Internet routers, firewalls, and primary and backup data storage upgrades. Site-based firewalls are being added to enhance the cybersecurity posture further.
