The LEA allocation of funds will be based on the recovery and acceleration of K-12 students. Data-driven decision making will propel budget planning as well as our 2023 achievement results. ESSER Allocations will be aligned to the state's Key Investments and allowable EIC Codes. Fiscal planning will be ongoing during FY23-24 as we monitor progress made in closing student learning gaps. Funding will be prioritized to ensure the implementation of our five-year strategic plan. The four priorities include: 1) Rigorous and engaging instruction, 2) Individualized support that ensures that all students are provided with Tier 1, Tier 2 and Tier 3 academic support to ensure mastery of grade-level content.

3) Maintain family engagement, and 4) Grow a diverse and talented workforce. Note that for 2023, the percent of students scoring Mastery and Advanced has improved in all subjects. All subjects are now above pre-pandemic levels. But the gap between white students and black students is still significant, and the percentage in proficiency increased at the same rate, which directs our response with actions and funding supports.

LPSB was awarded \$500,000 by the U.S. Department of Justice, Office of Community Oriented Policing Services (COPS) Grant to assist with the development of school safety resources. This funding will allow LPSB to establish and enhance a variety of school safety equipment and/or violence prevention programs to encourage the continuation and enhancement of school safety efforts within their communities. Such measures include:

- -Placement and use of metal detectors, locks, lighting, and other deterrent measures;
- -Security assessments;
- -Security training of personnel and students;
- -Coordination with local law enforcement;
- -Any other measure that may provide a significant improvement in security.

Through this program, LPSB requested funding for violence prevention initiatives and equipment for school sites in Lincoln Parish. Using COPS grant funds and ESSER funds, the following improvements will be made within the parish:

- 1. New Integrated Security Camera Systems at all schools
- 2. Exterior electronic access controls at all schools
- 3. Metal fencing and brick columns (protective boundaries) at Ruston High School
- 4. Mass communication and emergency notification system at two sites.

- e. Update internal connections (wireless access points, switches, etc.) at district facilities
- 3. Improve network and data security on end user devices by upgrading anti-virus software, implementing Multi-Factor Authentication (MFA) for enhanced network security, and upgrading VPN utility for remote network access.
- 4. Implement the information security continuous monitoring methodology with tools and software that will centralize the complete management of network firewalls, application control, intrusion prevention, and advanced malware protections.
