Students in grades 3 through 8 who failed to achieve mastery in any statewide assessment during the 2022-2023 school year and those not on track to score mastery during the 2023-2024 school year, will be prioritized and provided acceleration through "What I Need" (WIN) time to ensure they have an opportunity to address unfinished learning. Student performance on state assessments will be analyzed and those students not meeting the proficiency standard of mastery or better will also be prioritized to receive support through additional school staff, a high-quality tier 1 curriculum, 1:1 electronic devices, connectivity, access to summer programs, and afterschool programs. Based on the targeted learning support provided during the 2022-2023 school year, 45% of students were working at tier 1 and 2. Fannie C. Williams Charter School is working to ensure that students working below grade level will continue to grow academically. Based on the targeted learning support during the 2023-2024 school year we anticipate 75% of our students will be working at tier 1 or tier 2.
