The Purpose of tutoring at KIPP is to accelerate learning by increasing instructional minutes and supporting student academic progress with targeted, small group instruction aimed directly at students' needs that complement existing curriculum, focus on specific goals, and happen outside of the regular school day.

KIPP has a performance-based compensation structure with the purpose to provide professional development, coaching cycles, and a comprehensive evaluation process to promote the quality of performance. KIPP prioritizes matching students who need support with the most experienced and qualified teachers available to them. KIPP has certified mentor teachers at each school.

KIPP uses approved, tier 1 curriculum. KIPP's Academic Team works closely with the curriculum and provides coaching and support to schools. Curriculum is used for both standard instruction and accelerated intervention blocks.

School staffing models include additional teaching roles (Co-teachers & Interventionists) to ensure that all students who need support receive small-group and/or 1:1, grade-level accelerated instruction. Positions are assigned to specific groups of students to promote continuity of supplemental instruction.

Math Content Leaders in-training work with our KIPP Academics Team to build knowledge and expertise within the curricula, instructional strategies, and assessments. KIPP uses aligned, quarterly interim assessments and progress monitoring to maintain accurate data on student achievement and progress. KIPP fully implements the "Acceleration Cycle". KIPP's Co-Teachers and Interventionists work alongside lead teachers to implement the acceleration structure. After school tutoring is utilized when additional time is needed to ensure students are progressing. KIPP partners with Thrive Collective, an approved alternative evidence-based option, for math professional development.

KIPP continues to invest in both strategic and tactical enhancements of their IT operations through investments in people, process, and technology aligned with ensuring students and staff have reliable, resilient, and robust connectivity that is aligned to curricular goals and student achievement outcomes.

KIPP is focused on maintaining a proactive approach when it comes to procurement, installation, maintenance, and monitoring of their IT infrastructure. KNOS has undertaken strategic risk assessment efforts to define and serve as a guiding framework for these investments, and is adding senior staff, technology, and process to better support both staff and student populations.

In particular, KIPP is focused on ensuring that each campus has sufficient connectivity, resilience, and visibility. Enhancements at the network level will include replacement of aging, legacy equipment, as well as networked video cameras to support school safety and operations teams. Processes around help desk and remote administration will help ensure our technology teams are operating efficiently, and security enhancements involving both cloud services and local workstations and servers will harden our infrastructure against evolving threats.
