We have received the ThriveKids grant through the city of New Orleans, Children's Hospital, and NOLA-PS. ThriveKids, the Student Wellness Project, a multispecialty program intended to increase access to healthcare for kids where they spend most of their time - at school. The program was born out of the hospital's support of schools at the onset of the COVID-19 pandemic, and quickly evolved into a comprehensive health program that bridges the health and education sectors. ThriveKids, now nearly three years into formal programming, aims to improve both academic and health outcomes by getting the right resources to the right kids at the right time. The program helps staff schools with trained medical and mental health professionals, coordinates with schools to provide healthcare to children, and offers ongoing education for school faculty and partners. ThriveKids currently supports 180 campuses across Jefferson and Orleans parishes, consisting of more than 100,000 students combined. Students need to have access to and understand how to appropriately utilize educational technology. To respond to our additional literacy concerns, based on the success of the FastForWord program during the 2022-2023 school year, which resulted in average student growth of 1.6 grade levels when implemented with fidelity, we will be extending the use of this targeted intervention to support struggling readers who have been identified as Unsatisfactory or Approaching Basic as assessed on LEAP2025 during the 23 SY. Students will participate in this intervention for 30 minutes at least four days per week during the school's targeted Acceleration Block. CANO will expand support for students who did not score mastery or above on the state-wide assessments by providing these students with access to Tier I curriculum in all core content areas, when possible, these students will receive priority in placement in a teacher's class who has been identified as highly effective, and additional opportunities will be provided to gain mastery through targeted in class and afterschool tutoring. Each student will receive an Individual Academic Improvement Plan to identify specific areas of growth and ways in which their individual needs can be meet.

Teachers will be trained in the appropriate implementation of the identified curriculums and interventions to ensure correct implementation with fidelity. Proper training will ensure that students' needs are accurately and consistently being met to address unfinished learning because of the Covid-19 pandemic. We will also incentivize teachers in becoming highly qualified in their respective areas through stipends and additionally, we will pay for teachers to become certified or highly qualified to support our Network in providing students with the highest level of instruction from the highest qualified individuals. 3rd-8th grade will be prioritized in receiving access to highly qualified teachers, support from intervention staff, and Acceleration support. An Accelerated Learning Committee for students not achieving mastery will be formed and will include Principal The EL Coordinator and/or Special Education Teacher will also be included if applicable. These committees will work to evaluate student performance to create an academic plan to support student growth. We will also expand offerings of after-school tutoring to support students through targeted supports.

Additionally, we will apply the 50/50 Zearn model to support all novice teachers in math instruction as it parallels the Eureka Squared curriculum in a way to support deeper understanding of the standards at a rigor level that speaks to the rigor of the standards. All campus-based math leaders have attended (or will attend) the state provided Zearn professional development to deepen their understanding of appropriate implementation. This double block model will ensure that LDOE's pillars of high quality instruction, ongoing professional development, and parental engagement are happening across our network.
