Authority/History

The Special Education Advisory Panel (SEAP) advises and assists the Louisiana Department of Education (LDOE) with the provision of free and appropriate public education for individuals with disabilities. It exists by authority of the Individuals with Disabilities Education Act (IDEA) to provide guidance on special education programs and services. Members are appointed by the State Superintendent of Education after being selected from a pool of applicants by a committee that includes one member of the LDOE, one BESE member, and two current members of SEAP. SEAP members agree to serve three-year terms.
