

Below is a list of the data sharing agreements that are applicable to school systems. The agreements, by way of addenda, allow individual school systems to opt in, so that they may also receive the services provided and protect the privacy of their students. All executed LDOE data sharing agreements are posted in full [here](#).

This chart is a tool to assist in determining what agreements your school system needs to opt into and next steps.

- 1) Review the purpose of each agreement and determine if this agreement is needed in your school system.
  - a. Please note a few long standing agreements have expired, and a new agreement (same language with new dates) have been established. (see **\*UPDATED\***)
- 2) If the agreement is needed,
  - a. Check to see if your school system has already opted into the agreement by reviewing

  - b. If already opted in, no further action is needed.
