

Schools in Need of Intervention

Super App includes funding for the core components of school improvement at CIR, UIR-Academics, UIR-Discipline, and UIN sites.

Label	Criteria Cri
CIR	Schools that have been D- or F- rated for three consecutive years, or two years for new schools; and/or schools that have a graduation rate less than 67 percent; and/or schools identified as UIR for the same student group or for discipline for three consecutive years
UIR-Academics	Schools earned a score for one or more student groups that is equivalent to an "F" for at least two years
UIR-Discipline	The out-of-school suspension rate is more than two times the national average for the past three years
UIN	Schools earned a score for one or more student groups that is equivalent to a "D" or "F"



Managing Schools with Multiple Labels

While any school may have multiple designations, each school should only be focused on the one strategy that will have the most significant impact on the school.

UIR-Discipline

Systems with schools labeled UIR-D only have the opportunity to request up to \$10,000 to build the capacity of educators to provide support to students to be successful both personally and academically.

Systems requesting funding should identify the <u>underlying cause for the UIR-D label</u> and a strategy to address the underlying cause. This funding can be utilized to support professional development to address the identified underlying cause.



What's New in Super App Planning

CIR/UIR Requirements:

- **High-quality science curriculum** (P3.4.5) and Professional Development (P4.5.5) are now required in grades K-8 at CIR and UIR-Academic sites.
- School Improvement Best Practices (P4.5.9) and School Support Institute attendance (P4.5.13) are now **only required at CIR sites**, and are no longer required at UIR-Academic sites.



What's New in Super App Planning

Optional Funding Opportunities:

- Math Materials (P3.4.4) Purchase of eligible Math Refresh materials that accelerate learning for students at any site regardless of label.
- **Arts Curriculum** materials aligned to best practices (P3.4.8 9) Arts curriculum *at any site regardless of label*.
- Remedial English Dual Enrollment (P3.9.5) Remedial English Dual Enrollment courses for seniors at CIR and UIR-Academics sites.
- **New Teacher Supports** (P4.1.1) Induction programming, affinity groups, professional learning modules, and mentor support *at any site regardless of label*.



What's New in Super App Planning

Optional Funding Opportunities:

- **Teacher Leader Summit** (P4.5.10) Registration / travel costs of teachers & leaders attending 2023 Teacher Leader Summit at CIR / UIR-Academics sites implementing School Improvement Best Practices.
- **Strategic Planning Partnerships** (P4.9.4 5) Work with partners from LDOE's Strong School Systems Strategic Planning Partners list to develop 3- to 5-year strategic plans *in all school systems regardless of site labels*.
- **Content Leader Stipends** (P4.10.9) Stipends for each credentialed Content Leader who is leading professional learning or supporting other educators *at CIR schools*.
- Para to Teacher Training (P4.10.10) Paraprofessionals participating in a para to teacher training program at all sites regardless of label.



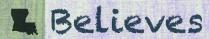


Lau Plans 2022-2023

- A Lau Plan is required of all school systems as part of federal civil rights law.
- The Lau Plan is named for the Supreme Court decision Lau v Nichols (1974) that established the foundation of EL programming in the U.S.
- The Lau Plan is designed to show how a school system is meeting the linguistic, academic, and well being needs of ELs through:

identification programming instruction assessment

The template can be found in the <u>Lau Plan Guidance 2022-2023</u>. Lau Plans are due on Monday, October 31.



Title III Consortiums


- Title III funds are available to school systems who meet the minimum enrollment count for ELs to equal \$10,000 (usually between 80-70 ELs).
- If a school system does not meet the minimum enrollment count for ELs, they can either join or form a Title III consortium.
- Title III Consortiums are a way to combine resources, ideas, and best practices to improve academic outcomes for ELs.
- See the <u>Title III Consortium Handbook</u> for more information and to learn about requirements.

All documents for new or continuing consortiums are due Friday, November 11.



CSPR

- The Consolidated State Performance Report (CSPR) for Title III is due Friday, November 18.
- All school systems that received Title III funds for the 2021-2022 school year must fill out the CSPR: Title III form.
- If your school system was part of a Title III Consortium, you will still need to complete the form.

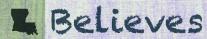


Equitable Updates and Services Reminders

Non-public Equitable Services Updates and Reminders

Updates from the National Ombudsmen Collaborative Session in Washington D.C. are as follows:

- The U.S. Department of Education is working on the updated Title VIII (II, III, IV) non-regulatory guidance and expects it to be ready this fiscal year.
- Schedule and document consultation meetings with non-public schools regarding the the use of ESSER I items, etc. still in use after September 30, 2022.
- Non-public schools will need to provide a justification in writing to the LEA during consultation to explain the need for continuous use of ESSER I items, etc.
- Be sure to communicate to non-public schools that do not want to continue to use the ESSER I items, etc., to consult with their LEA to determine a pickup/retrieval date and time. (Best to discuss and set a date/time during consultation.)
- The non-public school cannot keep/store unused ESSER I items; All items are the property of the LEA and must be returned if not in use.

Non-public Equitable Services Updates and Reminders con't.

Additional Updates from the National Ombudsmen Collaborative Session

- Be sure to have a representative sample of Family Income Surveys for your October first count.
 - If the non-public school has an enrollment of 300 students and each child was given a survey, a return of 75% 100 % (225 to 300 surveys) may constitute a reasonable representative sample for determining the low income count.
 - Non-public schools may also use their E-Rate and state scholarship data which low income qualifications are based on the same U. S. Department of National Food and Nutrition free and reduced lunch income scale.
 - The LEA determines what low income data will be used.
 - LEAs must document in timely and meaningful consultation notes which low income was discussed and used.
 - Pooling is voluntary and not mandatory; A non-public school may opt not to pool, even if other non-public schools pool their allocations.



Final Updates from the National Ombudsmen Collaborative Session

ESEA Non-public Complaints/Appeals...

- The number one goal is to, resolve the matter before a formal complaint is filed.
- Keeping an open-mind, beginning with the end in mind, which is a workable and agreeable relationship to find solutions and/or acceptance of federal guidance.
- Patience, listening, asking thought provoking questions and allowing all parties to be heard and provide input.
- Documentation and consultations are very important to resolving the matter(s), as well as, the final decision, next steps and/or appeals.
- Contact State Ombudsmen if needed and keep them abreast of all pertinent matters.
- Main concerns were... giving due consideration to non-public views during... timely and meaningful
 consultation/planning of for Non-public Title I Program and Title VIII allowable services, collection of
 poverty data, budget usage, documentation related to transferability, pooling and LEA non-public Title I
 services.









Updates/Reminders

2022-23 Super App Timelines

- August 31, 2022: Preliminary allocations for formula funding (ESSA and IDEA) were loaded in Super App.
 - Carl Perkins has been loaded in eGMS.
- Budget Additional Funding
 - Application in an "Approved" posture: will need to create an amendment to budget the additional funding.
 - Application in "Returned for Change" posture: funding will be visible and must be budgeted prior to re-submitting the application
 - Application in review process: will have to wait for the review process to complete to budget funding.

Note: Keep in mind that preliminary allocations could result in either an increase or decrease in funding. Funding decreases can be attributed to drops in census formula counts, changes in Multi-Stat data, decrease in total award from ED based on July 1 GANs, etc. LEAs that experience a decrease in funding can look at ESSER funding to potentially backfill any deficits.



Expiring Funds


LDOE sent out email communications to LEAs that have remaining balances in fund sources that have an 9/30/22 end date. Communication was sent to Superintendent, Business Managers and respective program staff for each fund source. (DSS expiring funds was sent in a separate email.)

Funding expiring 9/30/2022

- ESSA: FY20 and FY21 funding
- IDEA: FY21 funding
- ESSER I: Formula and Incentive funding (Strong Start application)

Next Steps


- Submit claims for at least the amount of the expiring funds amount no later than November 15, 2022. All expenditures must have occurred on or before September 30, 2022.
- ESSA/IDEA: will need to submit your 9/30 PER by November 15, 2022
- ESSER I: will need to submit your 9/30 PER marked as Final by November 15, 2022
 - If the LEA anticipates an unexpended balance for \$100,000 or more, please notify LDOE via <u>LDOE.GrantsHelpdesk@la.gov</u>. Subject Line: Unexpended ESSER I Funds
