






### **Believe to Achieve**


### **Use of Funds and Timeline**

Remember the ARP-HCY funds are intended to support the specific and urgent needs of homeless children and youth due to the extraordinary impact of the pandemic on students experiencing homelessness, including reduced identification of such students, decreased enrollment in school, interrupted classroom instruction, and challenges navigating services for shelter/housing, clothing and school supplies, food, and child care.

ARP Homeless I & II funds are available from April 2021 thru September 30, 2024.

Drawdown deadline is January 31, 2025

Reminder about comparable services: Any activity or service that is provided to all or any non-homeless students by an LEA cannot be reimbursed only for homeless students from ARP-HCY funds.


## General Guidelines Aligned with NAECHY Homeless Liaison Award Requirements



- Eligibility Requirements are aligned with NAEHCY Homeless Liaison Award requirements.
- The nominee must be a homeless liaison in a school system with a **minimum of three years' experience** working as a homeless liaison.
- LEAs (Federal Program Director or Superintendent) may submit one Homeless Liaison of the Year nomination.
- Nominations will be accepted from June 1 to June 15 of a calendar year.
- All award nominations are submitted electronically.

#### **NOMINATION CRITERIA**

- The nominee must clearly **understand the challenges** faced by children, youth, and families, including unaccompanied youth and preschool-aged children, as it relates to homelessness.
- The nominee must have a **thorough awareness and knowledge** of State and school district policies and other state and local policies that impact children and youth experiencing homelessness.
- The nominee must be **recognized as an expert in the field** and can meet the needs of children/youth experiencing homelessness, support and encourage academic success and implement cross-program coordination and community collaboration.
- The nominee must exemplify **leadership and innovation** regarding implementing and compliance with the McKinney-Vento Homeless Assistance Act.
- The nominee must be **well-known within their school system and community**. The nominee must have earned the admiration and respect of colleagues and community members.



## **Nomination Packet & Selection Process**




#### **Each nomination packet must include the following:**

- A minimum of three and a maximum of five letters of support
- A narrative outlining each of the following:
  - Information regarding the relationship between the nominee and the person nominating them.
  - A detailed description of how the nominee has met or exceeded the criteria indicated for that nomination.
  - An explanation of why the nominee is deserving of or qualified to receive this award.
  - Information related to the outcomes of the nominees' efforts
  - A headshot of the nominee
  - Although the following is not required, any other supporting documentation that you feel is important for your nomination – videos, presentations, a biography detailing accomplishment, newspaper articles, documents, etc., is strongly recommended to be submitted.

#### **SELECTION PROCESS**

- The **selection committee** will consist of Homeless Advisory Council members, two LDOE Federal Programs employees, LA State EHCY Coordinator, and Homeless Contract Consultant.
- Each set of documentation in the packet may receive a **score up to 20 points** from each of the committee members for each nominee (10 points- support letters, 5 points-headshot, 5 points-other documentation).
- The highest-scoring nominee will receive the award for the year.
- The SEA Coordinator will notify the award winner at the Annual Back to School Workshop August/September.







## Non-public Equitable Services Updates and Reminders

- Be sure you are having your budget meetings to update all non-public school principals, as well as Diocesan superintendent's/designee on their equitable services allocations and provide a mid-year Title I program review.
- After reviewing the budget, if the LEA will have a remaining allocation in non-public
  Title I, remember, this is for the LEA to expend during the school year or be used to
  prepare for a non-public Title I summer program and/or get materials/supplies needed
  for the fall equitable services.
- If applicable, be sure to share your Non-public Summer Title I plans and get input from non-public school administrators and Diocesan superintendents.



## Non-public Equitable Services Updates and Reminders

- Title II allocations may be used for materials and supplies that are only for professional development, such as: grade level/cross grade level collaboration, and school improvement collaboratives.
- Be sure to state the materials and supplies are for professional development on the requisition or purchase order, etc.
- There are only four or five months left to get additional site visits for this school year.
- Site visits should be apart of the end of the year LEA Non-public Title I evaluation.








## Louisiana FY21 ESEA Waiver

#### ED has approved the ESEA Waiver request for FY20 Funds.

This provides for the following:

- Carryover limitation in section 1127(b) of the ESEA for Federal fiscal year (FY) 2021 Title I, Part A funds (i.e., the Title I, Part A funds that will become carryover funds on October 1, 2022): to waive the requirement that limits a State education agency's ability to grant to its LEAs a waiver of the 15 percent Title I, Part A carryover limitation in section 1127(a) to once every three years.
- Period of availability of funds in section 421(b) of the General Education Provisions Act (GEPA): to extend the period of availability of FY 2020 funds for programs in which Louisiana participates under its approved consolidated ESEA State plan until September 30, 2023. The programs are: Title I, Part A; Title I, Part B; Title I Part C; Title I, Part D; Title II, Part A, Title III, Part A; Title IV, Part A, Title V Part B, & McKinney-Vento





- ESSER PER Completion Required for Accurate Reporting:
  - ESSER I Formula and Incentive:
    - <u>Final</u> PERs for 9/30/22
  - ESSER II Formula, Incentive, and School Choice:
    - Approved through at least 6/30/22
  - ESSER III Formula, EB, and Incentive:
    - Approved through at least 6/30/22
- Outreach will begin next week for LEAs not in compliance with the ESSER PER requirements.




