
Homeless Updates




McKinney Vento Funding

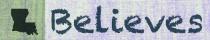
ARP Homeless I & II

ARP Homeless I & II Recipients: ARP Homeless I & II funds are available from April 2021 thru **September 30, 2024**. All claims are due by November 15, 2024.

Remember the ARP-HCY funds are intended to support the specific and urgent needs of homeless children and youth due to the extraordinary impact of the pandemic.

Homeless Liaisons will receive an email with current balances and a link to the Use of Homeless Funds Intent Form by Friday, June 2nd. Please complete the intent form by June 30, 2023.

Reminder about comparable services: Any activity or service that is provided to all or any non-homeless students by an LEA cannot be reimbursed only for homeless students from ARP-HCY funds.






Parent and Family Engagement Updates

3rd Annual PAFE Statewide Survey Administration

The Family Engagement Survey is an online survey designed to inform school systems and building leaders about their success at engaging parents in the education of their children. The 16 question survey is designed to be distributed to every student's parent/guardian.

The Survey evaluates the engagement of parents/guardians within five separate domains: welcoming environment for parents, collaboration with parents in supporting student learning, effective communication with parents regarding their children's education, sharing power and advocacy with parents and the facilitation of community involvement.

The survey is based on the National PTA Standards for Parent-School Partnerships, it is sensitive to change, is quick and easy to complete online, resulting in a high response rate.









- IDEA estimated allocations have been loaded in eGMS. Please amend the budget detail(s) accordingly. The Amendment 1 submission deadline is June 30, 2023

2022-23 Amendments

- June 22, 2023: deadline to submit amendments for all grants ending June 30, 2023.
- IDEA Final Allocations have been loaded in eGMS. Please amend the budget detail(s) accordingly and submit for review.
- Keep in mind that any FY20 and FY21 prior year formula funds the LEA may have will expire on 9/30/21.

Title I Waiver


- Waiver Approval from ED
 - Carryover limitation in section 1127(b) of the ESEA for Federal fiscal year (FY) 2021 Title I, Part A funds (i.e., the Title I, Part A funds that will become carryover funds on October 1, 2022): to waive the requirement that limits a State education agency's ability to grant to its LEAs a waiver of the 15 percent Title I, Part A carryover limitation in section 1127(a) to once every three years.
- If your LEA submitted a Title I Waiver request in eGMS Fiscal Year 2023, the approved request will not count as part of the one waiver every three years regulation.

Achieve: Release of Incentive Funds


- Release of Funds tab was made available on Friday, April 28, 2023.
- Release of Funds tab only applies to ESSER II Incentive and ESSER II School Choice funding.

When to use the Release of funds

• If an LEA has incentive funds that will not be expended/obligated on or before September 30, 2023

Deadline to Release Funds: August 4, 2023

Note: If the Achieve application is in an "Approved" posture, an amendment will need to be created to utilize the Release of Funds page.



Achieve: Release of Incentive Funds

Process for Release of Funds:

- LEA creates an amendment, completes the Release of Funds page indicating the amount to be released, and submits the amendment for approval. (Funding is not automatically removed from Allocations page.)
- On or before August 11, 2023, the reduction of funds indicated by the LEA will be completed in eGMS.
- LEA will create an amendment to adjust the budget detail and submit for approval.





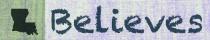
Achieve: ESSER II Formula Obligations

New Tab: ESSER II Formula Obligations

- Formula Obligations tab will be available today, June 15, 2023.
- Formula Obligations tab only applies to ESSER II Formula funding.

How to use the Formula Obligation of funds

- On your next Amendment submission, you will need to complete the obligations tab.
- The Allocation, Expenditure, and Remaining Balance amounts will be prepopulated
- Projected Obligation: LEA will enter the amount of remaining funds that will be obligated on or before 9/30/23
 - Capital Projects: LEA will enter the amount of the Projected Obligations that will be utilized for capital expenditures
- Projected Remaining Balance: the system will calculate




High Cost Services Rnd 1 Amendment 1

- High Cost Services Round 1 funding has been loaded into eGMS.
- In order for LEAs to be able submit claims timely, deadline to submit your High Cost Services Round 1 application amendment budget is <u>close of</u> <u>business June 22</u>
- Claims Submission Deadline: July 14, 2023.
- Fund Availability:
 - State: June 30, 2023
 - Federal: September 30, 2023.

2022-23 Redesign 1003a Funding

- The 2022-23 Super App funding has availability until 9/30/23.
 - Due to the current FY21 remaining balances, Redesign funding that is currently set to end on 6/30/23, will be carried forward into the 2023-24 application
 - 6/30 Final PER: Must be submitted timely to allow for carryover
 - Current LEA GANs will be updated to reflect this change in availability
 - Note: all FY21 funds must be obligated by 9/30/23
 - Claims must be submitted on or before November 15, 2023
 - There will be outreach from LDOE regarding remaining balances



SPED Cameras


The data collection tool portion of the eGMS SPED Camera application for school systems who received legislative funding allocations was due on May 31, 2023.


If you have not submitted this data, please do so no later than June 22, 2023.

The collection will request


- How many parent requests for cameras have you received?
