






Believe to Achieve






Stronger Connections Grant

- The Stronger Communities Grant (SCG) seeks to provide funding to school systems on a competitive basis to support school safety efforts.
- LDOE has designed a competitive sub-grant competition.
- Subgrants will go to "high-need" local educational agencies (LEAs) as determined by LDOE.
- Supplement not supplant and equitable services will apply to this grant.
 Louisiana's Award \$21,279,385 (one time funds)
 Funds Expire 9/30/2025





ELPT and ELPT Connect are being administered February 13-March 24, 2023.




Non-public Equitable Services Updates and Reminders

- Title IV allocations may be used to supplement on going strategies and programs.






- Transition of the GAN system is complete. Staff are working to publish GANs for 2022-23






