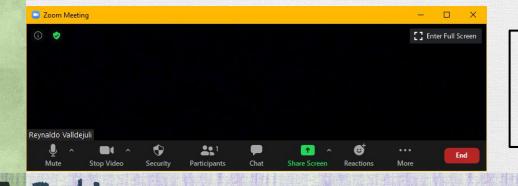





Verify Information	Planning lead verifies the accuracy of the application, receives approval from school system leadership, and ensures submission of the application by the due date.


### What's New in Super App

#### P4.5.12 CIR-Discipline

 Requests, up to \$10,000, for each CIR-D (only) school to support the implementation of the action plan.

#### P4.10.9 Recruitment and Retention

 Funds may be requested to support the career pipeline strategies the school system will use to increase the recruitment and retention of educators. Systems with CIR/UIR-A schools must select at least two strategies.

The evidence being provided meets one of the following two criteria (select either a or b):

A. Demonstrates a statistically significant effect on improving student outcomes or other relevant outcomes based on one of the following 3 types of evidence. (Note: evidence provided meeting this criteria is eligible for funding in Super App.)

- i. Strong evidence from at least 1 well-designed and well-implemented experimental study
- ii. Moderate evidence from at least 1 well-designed and well-implemented quasi-experimental study
- iii. Promising evidence from at least 1 well-designed and well-implemented correlational study with statistical controls for selection bias

B. Demonstrates a rationale based on high-quality research findings or positive evaluation that such activity, strategy, or intervention is likely to improve student outcomes or other relevant outcomes and includes ongoing efforts to examine the effects of such activity, strategy, or intervention. (Note: evidence provided meeting this criteria may be approved in Super App but funding <u>will not be provided</u> for an initiative with this level of evidence.)


