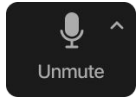
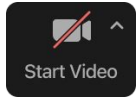


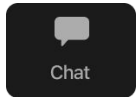

Louisiana RS 23:161: Minors; Prohibited Employment

- Revised Statute 23:161 allows minors to work as apprentices in a registered apprenticeship program with the Louisiana Workforce Commission.
- Exceptions of industry employment are listed in the attached document along with the full RS 23:161 Employment Privileges and Restrictions.
- This statute allows students to participate in a Registered Apprenticeship at age 16 (at provider discretion).

House Bill No. 1 ACT No. 447

- Funding based on the number of students enrolled in either fall, spring, and summer semesters in an eligible apprenticeship course
- Up to 500 student enrollments statewide
- \$3,500 per student - school system or school identified as rural by the [United States Census Bureau](#)
- \$2,500 per student - school system or school identified as non-rural

Funding can be utilized to support all of the costs associated with delivery of the apprenticeship services to the students.

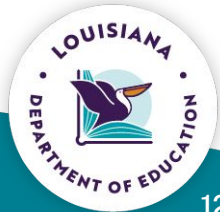
