



# EARLY CHILDHOOD NEWSLETTER

April 14, 2022

So many great things are happening within Early Childhood. Last month, the Louisiana Early Childhood Care and Education Commission released [Forging a Bright Economic Future: LA B to 3](#) that calls for an increased and ongoing state investment of \$115 million per year over the next decade to expand access to affordable, high-quality early care and education for children below age 3. The investment recommended by the Commission would help achieve the balance between the cost of quality early care and education and a family's capacity to pay that true cost of care. This would also increase access for more than 9,200 additional Louisiana children each year.

In addition to the Commission's bold plan to increase access, the Department is striving to increase the quality of early childhood classrooms as we prepare our young learners for kindergarten and beyond. The LDOE is inviting stakeholders to provide [public comment](#) and feedback on the state's [draft revisions of Louisiana's Early Learning and Development Standards \(ELDS\)](#). These drafted revisions are the culmination of a year-long effort led by a committee of early childhood experts and stakeholders from around the state. The standards serve as a framework for supporting the implementation of high-quality, developmentally-appropriate early childhood programs. These standards are intended to help early childhood educators and families across Louisiana deepen their understanding of how children grow and develop in order to best prepare them for kindergarten and beyond.

Louisiana must continue to be a leader in early childhood education and provide young children with high-quality learning opportunities.

## UPDATES FOR TEACHING AND LEARNING

### NEW: Early Learning and Development Standards Draft Revisions for Public Comment

The Louisiana Department of Education is inviting stakeholders to provide public comment and feedback on the state's [draft revisions of Louisiana's Early Learning and Development Standards \(ELDS\)](#).

During their April 6, 2022, meeting, the ELDS Review Committee unanimously endorsed the drafted standards revisions, which will establish a common vision for what the state of Louisiana wants children to learn before they enter kindergarten. The Department posted an online [public comment portal](#) to give stakeholders the opportunity to share their feedback on the revised standards and indicators. The portal can be accessed in the [Standards Review Committee Library](#) until May 9, 2022. The Department will consider the public's feedback to make further revisions and submit the updated Early Learning and Development Standards to BESE for approval in June.

## UPDATES FOR FUNDING AND ENROLLMENT

### **NEW: LA 4 and NSECD Reimbursements**

As a reminder, LA 4 and NSECD reimbursements will be made based on enrollment (up to, but not over the current seat allocation) January 2022 – May 2022.

LA 4 reimbursements (via funds labeled as TANF) for January 2022 were issued on March 14. LA 4 reimbursements (via funds labeled as SGF) for December 2021, January 2022, and February 2022 were issued on March 18.

NSECD reimbursements for January 2022 were issued on February 21, and reimbursements for February 2022 were issued on March 25.

### **NEW: American Rescue Plan Act (ARPA) Stabilization Grant Round 2 - Head Start/Early Head Start**

The ARPA Stabilization Grant Round 2 for CCAP-certified Head Start and Early Head Start centers, serving CCAP children in full-day, full-year programs, will be released April 25, 2022 and will close May 6, 2022. Payments will be released May 30, 2022 through June 10, 2022.

### **REMINDER: American Rescue Plan Act (ARPA) Stabilization Grant - Round 2 for Child Care Centers (NOT including Head Starts and Early Head Starts)**

The ARPA Stabilization Grant Round 2 has closed. Payments will be released on a rolling basis beginning May 2022. Please note that for all grants, providers must keep receipts and documentation of expenditures for the items paid from these funds. Also, providers must submit audit documentation upon request even if the provider has closed.

**REMINDER: Information on Timeframe and Uses of ARPA Stabilization Grants**

The Department issued this [letter](#) in response to questions about the timeframe of use of the ARPA Stabilization Grants. Included in the letter is the list of allowable uses with additional details. Please be reminded that ARPA Stabilization Grant funds may not be used for construction or major renovations, including land purchases.

**REMINDER: Federal and State Taxes on LaCAP Grants, ARPA Stabilization Grants, Etc.**

Grants provided through the stimulus funds (CARES, CRRSA, and ARPA) are subject to the same tax rules as regular CCDF funding. State tax rules apply; regarding federal rules, please contact the Internal Revenue Service for guidance. In some cases, funds used to cover operating expenses may be exempt from taxation.

**REMINDER: CCAP Underutilized Authorizations for Families and Paying on Enrollment**

CCAP conducts a monthly review of underutilized authorizations of children who have not attended child care within the previous month. The Tracking of Time Services (TOTS) Point of Service (POS) and Interactive Voice Response (IVR) attendance records are examined as part of the underutilization review. If a CCAP child has not attended at least one day in the month, the family is pulled for underutilization review.

The Provider Help Desk staff has been informing providers of the importance of families completing check in/out transactions when children are in attendance to maintain CCAP certification. If CCAP children are not attending, the Department will contact families to assess the need for continued child care services. If families are not reached during this period, their CCAP authorizations will be discontinued at the end of the month, and they will need to reapply for CCAP.

As a reminder, CCAP payments are based on enrollment, not daily attendance. **Again, the Tracking of Time Services (TOTS) Point of Service (POS) or Interactive Voice Response (IVR) must be used for CCAP children every day they are in attendance.**

## UPDATES FOR LICENSED CENTERS, FAMILY CHILD CARE, AND IN-HOME PROVIDERS

### **NEW: Emergency Preparedness and Evacuation Planning**

All providers must conduct tornado drills at least once per month. These drills shall be conducted in the months of March, April, May, and June at various times of the day; shall include all children; and must be documented. A [sample form](#), titled “Monthly Tornado Drills,” can be found in the Licensed Centers Library.

### **REMINDER: Email Contacts for Providers**

All providers should ensure that the center’s email address shared with the Department is an e-mail address specific to the center rather than specific to the center director or other staff member, in the event the director is no longer associated with the center. To request an update to your center’s email address, please email your licensing consultant or [ldelicensing@la.gov](mailto:ldelicensing@la.gov).

### **REMINDER: Motor Vehicle Passenger Checks**

It is imperative that vehicles are adequately inspected for children before staff exit the vehicle, especially as temperatures rise outside.

A staff person shall

- physically walk through the vehicle and inspect all seat surfaces, under all seats, and in all enclosed spaces and recesses of the vehicle interior.
- record the time of the visual passenger check and sign the log indicating that no child was left in the vehicle.

Please ensure staff have received proper training and repeated training if needed.

### **REMINDER: Decrease in Two-Year-Old Child to Staff Ratio for All Center Types**

Effective July 1, 2022, the child to staff ratio for two-year-olds will decrease from 11:1 to 10:1. Ensure you have sufficient staff to meet this requirement.

## UPDATES FOR COMMUNITY NETWORK LEAD AGENCIES

**NEW: Shadow Scoring Requirement for Spring 2022**

Currently, Bulletin 140 places three requirements on community network lead agencies for shadow scoring:

- 10% of all observations in each semester must be shadow scored



- Each local observer must be shadow scored
- Each network should perform a shadow score at least once in every age band observed during the year

Community Network lead agencies should review plans and identify action steps to meet these requirements during the 2021-2022 school year.

Community Network lead agencies should contact the Department if they anticipate requesting a waiver for specific observers who, through insurmountable obstacles, will not meet these requirements.
