



# Important News for **NONPUBLIC SCHOOLS**



**March 25, 2021**

Dear Colleagues,

Despite the heroic efforts of educators, students have lost out on more than academics during the pandemic. In many cases, they've also missed music, art, P.E, library visits and the social connection with classmates and educators. We're encouraging school systems to approach summer learning in a new way. The [summer learning program guidance](#) we released in February helps systems develop offerings that mirror summer camp. Along with core content tutoring in small groups, the sample structure we provided includes field trips, the arts, recess and well-being supports.

Summer learning programs offer additional opportunities for learning and growing during the summer months. Our guidance includes sample structures, schedules, staffing, academic offerings and enrichment activities school systems can use as they fund summer opportunities for incoming K-8 students. The guidance also recognizes the long-term benefits of systems connecting with community partners to support their work.

School systems can utilize multiple funding sources to support implementation. These include general funds, Title I, CARES, CAA and Direct Student Services allocations. We're pleased systems are considering our guidance utilizing their pandemic funding to rethink summer school. Families deserve the choice of full-day, enriching activities with high-quality educators.

Last week, the Centers for Disease Control and Prevention (CDC) revised its guidance on social distancing. The Louisiana Department of Health now recommends that, with universal masking, students should maintain a distance of at least 3 feet in classroom settings. The guidance also includes revisions for the use of physical barriers and partitions in schools. BESE President Sandy Holloway has approved revisions to the state's minimum COVID-19 health and safety standards for Louisiana school facilities. We've created [updated physical distancing guidelines](#) that cover some of these details. These changes will be covered in greater detail during Thursday's [Career and College Readiness call](#). It's our hope that these new guidelines will support teachers and leaders as we safely welcome more children back to our schools.

## **Equipment and Other Capital Expenditures - Edgar 200.439**

The Department is implementing a new process for school systems seeking pre-approval for equipment and capital expenditures.

The following types of expenditures would require use of the pre-approval process (Rules 1 & 3):

1. General equipment purchases (van, bus, etc.)
2. Land purchases
3. Building purchases
4. Improvement to general equipment, land, and/or building that increase the value or use life

The following rules of allowability must apply to equipment and other capital expenditures in accordance with Edgar 200.439:

1. Capital expenditures for general purpose equipment, buildings, and land are unallowable as direct charges, except with the prior written approval of the federal awarding agency or pass-through entity.
2. Capital expenditures for special purpose equipment are allowable as direct costs, provided that items with a unit cost of \$5,000 or more have the prior written approval of the federal awarding agency or pass-through entity.
3. Capital expenditures for improvements to land, buildings, or equipment that materially increase their value or useful life are unallowable as a direct cost except with the prior written approval of the pass-through entity (LDOE).

*Note: The eGMS application approval serves as pre-approval for special purpose equipment (servers, smartboards, body scan thermometers, etc.) Rule 2*

To submit a pre-approval request for equipment/capital expenditures please complete and submit the [Pre-Approval for Equipment/Capital Expenditures Form](#). The equipment/capital expenditure pre-approval form can also be accessed via the [FSGR Library](#). Once received, LDOE staff will review the request and provide either an approval or denial response to the request.

## **ESSER II Funding Guidance for Stipend Pay**

The Louisiana Department of Education generally disclaims consideration of the following as an allowable use of ESSER funds, under any part of 18003:

1. Subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs, or
2. Expenditures related to state or local teacher or faculty unions or associations.

ESSER funds generally will not be used for bonuses, merit pay, or similar expenditures **unless related to disruptions or closures resulting from COVID-19.**

## **Pandemic Relief Funding Allowability Correction**

The Department is releasing corrected language regarding the use of pandemic relief funding. This information has also been updated in the [FAQ](#).

### **Can ESSER II funding be used to provide stipend pay for employees?**

The Department generally does not consider the following to be an allowable use of ESSER funds, under any part of 18003 of the CARES Act:

- Subsidizing or offsetting executive salaries and benefits of individuals who are not employees of the SEA or LEAs, or
- Expenditures related to state or local teacher or faculty unions or associations.

ESSER funds generally will not be used for stipends, merit pay, or similar expenditures, unless related to disruptions or closures resulting from COVID-19.

School systems can use ESSER funds to provide stipends for faculty and staff if those are related “to preventing, preparing for, and responding to coronavirus.” Below are additional compensation examples:

One-time stipends to address pandemic-related recruitment or retention challenges

- Additional compensation to teachers and other staff that work in-person
- Additional compensation to teachers and other staff that have assumed new duties because of pandemic
- One-time stipends to incentivize effective teachers to move to schools with vulnerable students disproportionately impacted by the pandemic
- Additional pay to substitute teachers where there are shortages

#### **NAEP 2021**

- **Additional Monthly Survey**
  - By Executive Order, a NAEP 2021 Monthly School Survey will be collected from approximately 90 schools in Louisiana to understand the impact of COVID-19, including the status of in-person learning.
  - Nationally, the survey will collect data from approximately 3,500 schools that enroll fourth-graders and an equal number of schools that enroll eighth-graders.
  - The submission windows have been extended to accommodate spring break (March 17-26, April 14-23, May 24-28, and June 21-25).
  - The status of in-person learning will be disaggregated by student demographics, including race/ethnicity, disability, English Learner status, and an economic disadvantage indicator.

- The public will have access to data about school reopenings for in-person instruction and how students are learning.

## ***Federal Support and Grantee Relations Reminders***

### **Title IV, Part A, CARES Act Fiscal Waiver Flexibilities for SY 2020-2021**

In addition to the Title IV Waiver Flexibilities currently available for Title IV, Part A Funds for 2019-2020 **prior year** funds, all school systems are encouraged to take advantage of the Title IV Fiscal Waiver Flexibilities for the current year, SY 2020-2021, Title IV award.

These recently extended fiscal waiver flexibilities allow local school systems to apply the following provisions to the current school year 2020-2021:

- Target Title IV, Part A funds directly to specific needs of school systems within the intent of Title IV programming without having to adjust the Title IV Needs Assessment.
- Disregard the Content Area 'Required Percentages' in order to get the maximum fiscal flexibility driven by the school system's current needs. For example, school systems will be allowed to target more funding toward technology infrastructure (i.e. student devices, internet connectivity, etc.) without being limited to the fifteen percent requirement for Infrastructure/TIN in the Effective Use of Technology section.

School systems can access the Title IV fiscal flexibilities immediately by amending their 2020-2021 Super App. The following areas must be amended:

1. Signing off on the Title IV waiver assurances
2. Noting changes on the Amendment Description tab
3. Aligning actual amounts projected on the Title IV Allowable Uses Page
4. Adjusting the appropriate Domain Budget Detail page

Note: These flexibilities apply to Title IV, Part A funds for the prior year 2019-2020 and current year 2020-2021 currently available in the 2020-2021 Super App for each LEA.

### **LEAP 2025 Graduation Regulatory Flexibility Options for 2020-2021**

**Please share with secondary supervisors, high school administrators, district test coordinators, and counselors.**

Due to the ongoing COVID-19 pandemic, the Board of Elementary and Secondary Education has granted a [LEAP 2025 graduation regulatory flexibility options](#). This option will allow opportunities for high school seniors to meet the LEAP 2025 and Career Diploma IBC credentialing requirement. The aforementioned opportunities are available to high school seniors who meet the following qualifications:

1. Met all other graduation requirements
2. Attempted all LEAP 2025 assessments at least one time
3. Were enrolled during the spring 2021 semester and are graduating by August 31, 2021

All high school seniors who meet the qualifications listed above have the option to substitute the following in lieu of the LEAP 2025 high school assessment requirement and/or Career Diploma credential requirement:

#### **LEAP 2025 Substitution Opportunities**

1. An ACT composite score of 17 or higher for all students; or
2. An ACT subject score of 17 or higher in the corresponding LEAP 2025 high school assessment; or
3. A score of Silver or better on ACT WorkKeys for students pursuing a Career Diploma; or
4. The student participates in 20 or more extended learning hours per LEAP 2025 high school assessment subject pair for which the student has yet to achieve level 2 (approaching basic/fair) or above, with such instruction provided by a qualified teacher. A template will be provided to LEAs to document the extended learning hours and the level of achievement.
  - a. School systems will determine the number of extended learning hours needed (minimum 20) and the assessment method used to determine whether or not the student is performing at the equivalent of Approaching Basic
  - b. Qualified teacher is defined as holding a valid and current teaching certification or a final COMPASS evaluation of Effective: Emerging or better

#### **Career Diploma IBC Credentialing Requirement Opportunity**

1. WorkKeys Silver and above can also substitute for an IBC credential for the purpose of meeting graduation requirements for Career Diploma students.
