All families (including Orleans) who need to submit applications for the 2024-2025 school year must apply using the LDOE website. Parents will be able to access the <u>application</u> on December 11th on our <u>website</u>.

- New applicants, students who wish to transfer to another participating scholarship school for the upcoming year, and those in a terminal grade will need to submit an application for the 2024-2025 school year.

#### Title I, Part A & D Data Submission

The LDOE must report student data for participation in Title I, Part A & D in the Consolidated State Performance Report (CSPR). Data will be collected in the <u>LEADS portal</u>. The portal is now open for data submission until January 5. The annual count for Title I, Part D will be collected in the <u>LEADS portal</u> under the annual count tab. The count will determine funding for neglected and delinquent facilities under the Every Student Succeeds Act (ESSA). Complete tables 1-5 for the CSPR. Data submitted for tables 1-5 is from SY 2022-2023. This request is only for school systems that receive Title I, Part D funds. LEAs and charters that receive Title I, Part A funds must complete this request.

The spreadsheet can be accessed by local CIS administrators from the evaluation tab in CIS. The deadline to upload 2022-2023 leader evaluations is January 8. Only leader evaluations can be uploaded as the deadline has passed for all other evaluation types. No evaluations may be entered or <u>uploaded</u> following January 8. Early entry is encouraged to allow time for troubleshooting technical concerns.

# <u>Compass Information System (CIS) and Evaluation Updates and Resources</u> Please share with human resource directors, school leaders, system leaders, and teachers.

The <u>Compass Information System (CIS)</u> is open for 2023-2024 evaluation data entry. The <u>2023-2024 CIS Timeline</u> provides a suggested timeline to ensure timely entry of all data. Local CIS administrators may monitor data entry using the <u>Completion Report</u>. As a reminder, evaluation data in CIS aids in the process of certification renewal and advancement.

Per <u>Bulletin 130</u>, all school leaders and teachers require a minimum of two observations/site visits and two student learning targets (SLTs). Please refer to the following resources to complete the evaluation process.

#### **Educator Evaluation Pilot Update**

Please share with human resource directors, school leaders, system leaders, and teachers.

The Educator Evaluation Pilot year is underway with 17 systems piloting updates to the evaluation system. The Louisiana Educator Rubric is being utilized for three teacher observations. The evaluation process includes a professionalism survey, self-assessment, follow-up coaching cycles based on refinement areas, and student surveys to gather additional information. The Louisiana Leader Rubric is being utilized for leaders. The leader evaluation process includes goal setting, two formal scored conferences, self-assessment and teacher surveys.

The learning year will take place in 2024-2025. The new evaluation system will be implemented in all school systems, therefore Compass will not be used. Face-to-face training for system and school leaders, as well as designated observers, will take place this summer. Training dates will be released soon and registration will open in January.
