Dear Colleagues,

April is the Month of the Military Child. Just like all Louisiana children, our educators work to ensure every military-connected child is college or career ready. Military children face challenges unique among our students, whether the deployment or reintegration of a parent or adjusting to frequent moves.

Nationally, there are around 1.2 million active-duty connected children and over 80 percent of those children are in U.S. public schools. In Louisiana, we have just over 11,000 military-connected children. While the majority of our military families are concentrated in a handful of parishes, there are military-connected children in almost every Louisiana school system.

Approximately 200,000 school-age, military-connected children move each year. Studies show that military-connected families average six to nine moves from kindergarten to graduation. This is three times higher than civilian families, and these moves are more likely to be across state lines or national boundaries.

As educators, it's important we ensure an equitable and inclusive environment for all children. Some of the ways to help ease the transitions and challenges faced by our military families include supporting course placement and credit transfers, along with promoting student well-being. The first step to supporting these children, however, is simply being aware of the responsibility that comes from serving these students and sensitive to the needs of their families.

I'm grateful for the service of our military families. The men and women in our armed forces dedicate their lives to defend the freedoms we have as Americans. It's an honor to educate the children of these heroes. Louisiana proudly joins the nation celebrating our military-connected families this month and every month.

#### **ESSER Funding Summary for Superintendents – April 2021**

LDOE is releasing [estimated ESSER II and III allocations](#) to school systems in two action periods in order to:

- Meet federal requirements for awarding funds to LEAs\*.
- Support strategic and coordinated response efforts through 2024.
- Ensure school systems are spending down their ESSER I funds first.
- Help school systems meet the 20 percent requirement of ESSER III.

*[\\*SEAs must award ESSER II funds within one year of receiving them, which will be January 2022. SEAs must allocate ESSER III funds in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives those funds.](#)*

#### **Achieve! Strategic Planning and Budgeting**

**Planning:** School systems should **use the full estimated allocation amounts to develop multi-year plans** that include high-impact initiatives in alignment with the allowabilities and priorities.

**Budgeting:** School systems will **submit budgets April 30 for the amount loaded into eGMS**, which is 50 percent of ESSER II and 20 percent of ESSER III formula funds.

*Remaining funds from FY21 will automatically carry forward in eGMS to FY22 on July 1, 2021.*

As school systems develop and revise plans, they will be able to make budget revisions throughout the life of the grant. **Once additional funds are allocated and loaded into eGMS, school systems will amend their budgets to include those amounts.**

The school fact sheet includes information for schools that are served by or are public water systems (PWSs). The child care fact sheet is intended for facilities specializing in early care and education programs, including center-based and family child care homes, pre-kindergarten programs, as well as Head Start and Early Head Start Programs. Additional considerations are included for child care facilities that are non-community water systems (NCWSs), and child care facilities served by a private well.

## **For District Testing Coordinators and Accountability Contacts**

### **LEAP 2025**

### **Third Year Assessment Cohort Roster**

- Third-year assessment cohort rosters have been posted to school system FTPs. These students must participate in English I and Algebra I testing, regardless of course enrollment, unless there is an appropriate accountability code to apply to their record.
- These students have been preloaded to DRC INSIGHT. They should not be removed. The students should either be tested or coded out.

### **Assessment Development Educator Review Committees**

- The Division of Assessments, Accountability, and Analytics will convene LEAP 2025 and LEAP Connect assessments committees in June and July via teleconference.
- LEAP 2025 Science and Math Content, Bias, and Sensitivity committees will review newly developed assessment items and provide feedback and recommendations on the items.
- LEAP Connect Standards Validation and Standards Setting committees will work on cut scores and achievement levels for ELA, math, and science assessments.
- **May 9 Deadline to Apply:** Interested educators should access the [Assessment Development Educator Review Committees document](#) for information on exact dates, meetings details, and links to apply to participate on specific committees. Selected participants who are on summer break are eligible to receive a daily stipend. Please share this announcement with general education teachers, special education teachers, teachers of English Learners, school and school system supervisors, and school administrators – all are encouraged to apply.

### **Data Certification**

- Cohort graduation data certification is now open and will remain open until April 23 in LA Data Review for 2019-2020 graduates. Individual emails were sent to accountability contacts to confirm dates and provide user access and support materials.
- Additional information may be needed for data certification submissions. Accountability contacts should check regularly for messages from Department reviewers.
- Please be sure contacts are updated. Access to the system will only be provided to official accountability contacts.
- Audits will be conducted on students who exited as out-of-state transfers, nonpublic school transfers, and BESE-approved home study transfers. FAFSA parental opt-outs will also be audited.
- Superscores are now visible for any student that has taken 2 or more ACT battery tests.
- Superscores will not be used for TOPS eligibility and there are no plans to use them in accountability at this time.
- April 1-3: Superscores were rolled out only available in the “All Data” tab in Online Reporting according to the following schedule:
  - April 1: Download Hub now includes Superscores for all years available in the platform
  - April 1-3: Superscores rolled out for current year (2020-2021).
- End of April: Superscores for historical years will be visible in the roster and aggregate reports.

#### NAEP 2021

- **Additional Monthly Survey**
  - By Executive Order, a NAEP 2021 Monthly School Survey will be collected from approximately 90 schools in Louisiana to understand the impact of COVID-19, including the status of in-person learning.
  - Nationally, the survey will collect data from approximately 3,500 schools that enroll fourth-graders and an equal number of schools that enroll eighth-graders.
  - The submission windows have been extended again to add days to each window (April 14-27, May 19-June 2, and June 16-29).
  - The status of in-person learning will be disaggregated by student demographics, including race/ethnicity, disability, English Learner status, and an economic disadvantage indicator.
  - The public will have access to data about school reopenings for in-person instruction and how students are learning.

- **Student and Teacher Questionnaire**

## School Improvement

### **School Improvement Best Practices Launch**

As mentioned in the April System Leaders' Monthly Call, the Office of Teaching and Learning is excited to announce the creation of the Division of School Improvement. The purpose of the Division of School Improvement is to provide school systems and leaders with differentiated and targeted support that will result in improved student outcomes. This support is aligned with the Department's critical goals of providing the highest quality teaching and learning environment and removing barriers and creating equitable, inclusive learning experiences for all children.

The Division of School Improvement will support school systems and leaders in achieving these critical goals through the implementation and use of the School Improvement Best Practices.

The School Improvement Support Specialists (SISS), formerly known as Network Coaches, will partner with school systems in conducting paired observations, collecting data around paired observations, and using that data to inform targeted feedback given to school leaders to improve their quality of practice. This strategy is a shift from SISS supporting schools to supporting school systems. This shift will ensure the Department is building capacity within systems to sustain the work of school improvement at the local level. The targeted support is focused on Best Practices for Instructional Leadership Teams, Teacher Collaboration, Teaching and Principal Standards, and Career Pipeline. As a result of this shift, all students in priority schools will have access to a high-quality education and will meet their ambitious growth goals each year.
