# CHARTER SCHOOLS

Dear Colleagues,

This week we publicly released a new initiative aimed at sparking a reading revival across our state. [Louisiana Literacy](#) was developed to help ensure every child can read on grade level and graduate ready to succeed after high school. Being able to read is a foundational goal in education, and we must refocus efforts to support this basic need for students.

Unfortunately, more than half the students in our elementary and middle grades are reading below level in Louisiana. Only 40 percent of Louisiana kindergarteners, 42 percent of first graders, 48 percent of second graders and 50 percent of third graders are on or above grade level in literacy, according to the statewide fall reading report. This represents multiple years of literacy declines. Further, only 46 percent of students have mastered ELA content by the end of their third-grade year. Louisiana Literacy provides literacy supports for teachers, leaders and families that emphasize high-quality instruction and resources based on the science of reading.

[School systems, schools and families can now access resources on our website.](#) This initial round of resources focuses on early literacy and foundational skills. We are currently developing tools for all grade levels. In addition to some of the online resources listed below, we will provide professional development customized to support specific schools, students and curriculum. This past Friday, the U.S. Department of Education (ED) released its [school reopening guidance](#). Our [Accelerate](#) tutoring initiative is featured as a national example of how school systems can address unfinished learning. It's reaffirming to see the work we're doing in Louisiana called out as a strategy schools around the country can use to help children get back on track. Not only is Louisiana a national leader for safely providing in-person instruction, but our students are benefitting from academic strategies proven to move students forward.

## **Pandemic Relief Funding: Strategic Budget Planning Support**

## **Developing and Enhancing School Emergency Operations Plans Virtual Training**

This no-cost, 4-hour virtual training covers a six-step planning process that enables schools to produce a comprehensive, all-hazard emergency operations plan (EOP). Participants will discuss the collaborative planning process, potential planning partners both within the school system and the response community, the structure and functions of an all-hazard plan, and best practices for creating functional and hazard-specific annexes tailored to the unique needs of schools.

The course will provide a comprehensive overview of potential planning partners for school emergency management, an understanding of the collaborative planning process, and the basis for a complete and comprehensive, all-hazards school emergency operations plan.

This workshop is intended for district or school administrators, principals, teachers, school psychologists, facilities managers, transportation managers, school resource officers, and community partners with roles in creating and maintaining school crisis plans and emergency operations plans.

#### **Third Year Assessment Cohort Roster**

- Third-year assessment cohort rosters have been posted to school system FTPs. These students must participate in English I and Algebra I testing, regardless of course enrollment, unless there is an appropriate accountability code to apply to their record.
- These students have been preloaded to DRC INSIGHT. They should not be removed. The students should either be tested or coded out.

#### **Assessment Development Educator Review Committees**

- The Division of Assessments, Accountability, and Analytics will convene LEAP 2025 and LEAP Connect assessments committees in June and July via teleconference.
- LEAP 2025 Science and Math Content, Bias, and Sensitivity committees will review newly developed assessment items and provide feedback and recommendations on the items.
- LEAP Connect Standards Validation and Standards Setting committees will work on cut scores and achievement levels for ELA, math, and science assessments.
- **May 9 Deadline to Apply:** Interested educators should access the [Assessment Development Educator Review Committees document](#) for information on exact dates, meetings details, and links to apply to participate on specific committees. Selected participants who are on summer break are eligible to receive a daily stipend. Please share this announcement with general education teachers, special education teachers, teachers of English Learners, school and school system supervisors, and school administrators – all are encouraged to apply.

#### **Data Certification**

- Cohort graduation data certification is now open and will remain open until April 23 in LA Data Review for 2019-2020 graduates. Individual emails were sent to accountability contacts to confirm dates and provide user access and support materials.
- Additional information may be needed for data certification submissions. Accountability contacts should check regularly for messages from Department reviewers.
- Please be sure contacts are updated. Access to the system will only be provided to official accountability contacts.
- Audits will be conducted on students who exited as out-of-state transfers, nonpublic school transfers, and BESE-approved home study transfers. FAFSA parental opt-outs will also be audited.
- Superscores are now visible for any student that has taken 2 or more ACT battery tests.
- Superscores will not be used for TOPS eligibility and there are no plans to use them in accountability at this time.
- April 1-3: Superscores were rolled out only available in the “All Data” tab in Online Reporting according to the following schedule:
  - April 1: Download Hub now includes Superscores for all years available in the platform
  - April 1-3: Superscores rolled out for current year (2020-2021).
- End of April : Superscores for historical years will be visible in the roster and aggregate reports.

#### **NAEP 2021**

- **Additional Monthly Survey**
  - By Executive Order, a NAEP 2021 Monthly School Survey will be collected from approximately 90 schools in Louisiana to understand the impact of COVID-19, including the status of in-person learning.

- Nationally, the survey will collect data from approximately 3,500 schools that enroll fourth-graders and an equal number of schools that enroll eighth-graders.
- The submission windows have been extended again to add days to each window (April 14-27, May 19-June 2, and June 16-29).
- The status of in-person learning will be disaggregated by student demographics, including race/ethnicity, disability, English Learner status, and an economic disadvantage indicator.
- The public will have access to data about school reopenings for in-person instruction and how students are learning.

- **Student and Teacher Questionnaire**

#### **USDA Child Nutrition Program Emergency Operational Costs Funding**

On March 15, the USDA Food and Nutrition Service (FNS) published additional [implementation guidance](#) and [Q&As](#) regarding the Child Nutrition Program Emergency Operational Costs programs. This guidance is in addition to the previous [guidance](#) and [Q&As](#) released by USDA on January 26. Under this authority, FNS is offering additional funds to State agencies administering the National School Lunch Program (NSLP), School Breakfast Program (SBP), and the Child and Adult Care Food Program (CACFP) to provide eligible program operators with additional reimbursements for emergency operating costs they incurred during the public health emergency. Eligible program operators will not be required to submit an application to receive the funds, which will be distributed according to the formula prescribed by FNS in the guidance.

## **Community Eligibility Provision (CEP) Deadline and Data Collection Flexibility**

The United States Department of Agriculture (USDA) recently announced the availability of the [Nationwide Waiver of Community Eligibility Provision \(CEP\) Deadlines](#), which extends annual CEP deadlines for the 2021-2022 school year. School systems must finalize CEP elections no later than **September 30**. Additionally, school systems electing CEP, establishing a new ISP, or conducting a grace year for the 2021-2022 school year may calculate the Identified Student Percentage (ISP) using data drawn at any time during the prior school year (July 1, 2020, through June 30, 2021). ## ***School System Financial Services Reminders***

### **Maintenance of Effort (MOE) Fiscal Requirements**

**Please share with business managers and financial officials.**

Meeting yearly Maintenance of Effort (MOE) requirements are part of the business process to confirm compliance and determine eligibility of federal grant funds for ESSA and IDEA grants. ED requires an annual review that determines if each LEA: 1) has not decreased spending of general fund dollars, and 2) is budgeting expenditures to meet the MOE standards.

There are three MOE measurements submitted in the eGMS system:

- 2020 IDEA MOE Confirmation (Compliance) deadline for submission is **May 14**.
- 2022 ESSA MOE Verification updates are in progress and will be available in the near future.
- 2022 IDEA MOE Verification (Eligibility) updates are in progress and will be available in the near future.

### **COVID Relief Funds and MOE**

Although school systems have received relief funds as a result of COVID-19, these funds do not affect the Maintenance of Effort requirements at the LEA level. LEAs are required to continue spending at levels to continue to meet all MOE requirements in accordance with previous federal regulations. Federal requirements have changed at the State level only.
