Superintendent's Message

Dear Colleagues,

High schools are different from elementary and middle schools in essential ways. Students are older and more independent. The curriculum is more diverse. Teachers are often organized into departments rather than teams. It can be easy for kids to slip through the cracks of high schools.

Yesterday, the Department [announced](#) that 31 high schools across the state - rural and urban, traditional and alternative, large and small - will join in a collaborative effort to increase dramatically the graduation rates and credentialing rates of their students. Partnering with nationally respected professor Robert Balfanz and his team at the Everyone Graduates Center at Johns Hopkins University, these schools will convene throughout 2018 and 2019 to design the structures and processes necessary to support high-needs students as they progress through high school. This will mean organizing schools so that teams of teachers are in touch with one another about the needs of specific students. It will mean long-term planning with students so that they can reflect on their path to a funded education after high school. And it will mean managing data in an organized fashion, so that when students are absent or struggling help is on the way.

The state will soon release class of 2017 graduation rates and credentialing rates. This announcement will highlight in one respect that our state has made great strides in advancing the education levels of high school students. Our [recent progress](#) in financial aid form completion is another testament to this. The future is brighter for many thousands of young Louisianans today because of our high schools' efforts.

But the report will also inevitably highlight that many young people in Louisiana fail to attain the most basic of benchmarks in our public education system, a high school diploma. Louisiana [tops the nation](#) in the percentage of its young adults who are neither enrolled in a school or college nor employed in a full-time job. That stat is perhaps the least promising indicator for the future of our state. And it is something we have to change.

That starts with high schools that are organized around the needs of students, that know their students and their daily lives, and that intervene when trouble is ahead. It is about high schools who make sure students are reflecting on their results and planning for the future. It is about high schools with systems and processes for making these simple things happen, so that more students go on to the next phase of their life with a chance of upward mobility and a productive life ahead. Thanks to these 31 schools for taking on that ambitious mission.

The [2018 Teacher Leader Summit](#) will take place **Wednesday, May 30 through Friday, June 1 at the Morial Convention Center in New Orleans**. This event will bring together 6,500 educators and content experts from across the state to share their knowledge, and learn new skills to ensure meaningful growth for every child, every day in 2018-2019.

Registration for the Summit is now open in [WisdomWhere](#) and is based on a first come, first served basis, with a small subset of sessions requiring pre-registration. Registration will close in mid-May.

In Louisiana, we believe that all students, even those that struggle the most, should have access to the best education. At this year's Teacher Leader Summit, **educators will have the opportunity to choose from over [300 sessions](#) led by content experts, and should plan to attend all three days**. Approximately 70 percent of sessions will focus on topics relevant to classroom teachers, therefore school systems are encouraged to ensure approximately 70 percent of their attendees are current classroom teachers.

This year's event will also include "Ed Talks," a series of nationally recognized speakers and accompanying session tracks that will provide schools and schools systems with innovative strategies to best support struggling students and schools. Details will be provided in early May via the newsletters.

Assessment and Accountability

New: Action Items and Important Information for District Testing Coordinators

General

- All changes to district test coordinators (DTCs) or accountability contacts must be submitted to the Department using the [DTC and Accountability Contact Update](#) form found in the Assessment Library.

LEAP 360

- LEAP 360 Interim Assessment District Item Response Files, School Test Session Summary Reports, and Test Session Summary Reports were posted for all forms on April 23. The remaining scheduled postings will be May 7, May 21, June 4, and June 18.

LEAP 2025

- Test setup for grades 3-8 and high school is now open. Test coordinators can schedule test sessions, assign students to sessions, and verify accommodations. STCs can use the [eDIRECT User Guide](#) for step-by-step directions.
- Now - May 4: LEAP 2025 grades 3-8 computer-based testing window
- Now - May 18: LEAP 2025 high school computer-based testing window
- April 30 - May 4: LEAP 2025 grades 3-4 paper-based testing window
- May 7-8: Grades 3-4 PBT makeup window
- DTCs should ensure schools are running the readiness check before testing each day. Schools should open INSIGHT, select the purple check mark in the bottom left corner, and type 7745. If the screen does not show all green check marks, the technology coordinator should be notified.
- DTCs needing the unsent response flags cleared can now contact the Department assessment hotline to have those flags removed. Please check and ensure all responses are cleared from the TSM prior to calling the Department.

New: AEPS to TS GOLD Transition Deadline and Supports

As of July 1, Teaching Strategies Gold (TS GOLD) will replace AEPS as the assessment tool used to measure the progress and growth of 3-5 year old children with disabilities. Data

New: 2017-2018 Teacher Roster Verification for VAM and TSG

The Curriculum Verification and Results (CVR) Reporting Portal roster verification process ensures that teachers are assigned to the correct courses and classroom rosters for the purposes of value-added (VAM) and transitional student growth data (TSGD) analyses.

In 2017-2018, VAM results will account for 35 percent of the Student Growth component of the teacher's final evaluation.

- Teachers in grades 4-8 in ELA, Math, and Social Studies will receive VAM results.
- Teachers in Algebra I, Geometry, and English I will receive TSG results in 2017-2018 because these assessments are in transition to new achievement levels. These TSG results are for information purposes only and will not count in the teacher's final evaluation.
- Teachers in other grades and subjects will not receive VAM or TSGD scores.

May 7-18: The CVR portal will be open for roster verification. During this time, users can view and check the roster data for accuracy, and make changes in the system.
