Superintendent's Message

Dear Colleagues,

In early education and K-12 education, we often find ourselves so focused on immediate goals that the long-term nature of our work becomes an afterthought. Education can transform lives and societies, but these transformations take time. The path from child to adult is necessarily a long one, and disrupting the cycle of poverty takes years of intensive effort while traveling that path.

There are as many educational paths out of poverty as there are individuals walking that path. For some, it will involve outstanding performance from elementary school through university. For many, it will involve workplace-based education and time in community colleges. For most, it will involve ups and downs, characterized by persistence in the face of challenges. But in nearly all cases, it will involve continuing one's education.

College looks different for different people. College may mean learning to nurse, learning to weld, learning to code, or learning to read philosophy. But in all cases, continued education matters. It is the best means the education system can offer high school graduates seeking to create a life full of opportunity.

Yesterday, the Department [announced](#) that the class of 2017 saw more students enroll in college in the fall following graduation than any class in the state's history. The number of graduates attending college each year has now increased by more than 3,000 students since 2012, a 15 percent increase.

At the state level, establishing a college-going culture has involved support for the ACT, Jump Start, Advanced Placement, CLEP, TOPS and Jump Start aligned dual enrollment courses, and financial aid planning. But a college-going culture takes leadership at the district and school levels above all else. On behalf of thousands of young people disrupting the cycle of poverty, I thank you.

One more note of thanks: Assistant Superintendent [Jenna Conway](#) has led the state's early childhood efforts for the last six years, since the passage of Act 3. In that time, Jenna has worked with every parish to bring together the fragmented pieces of the early education system in Louisiana and has set an enduring bar for quality in the process. Next month, Jenna will be leaving the Department to return to Virginia, her home state, where she will work for Governor Ralph Northam on his early education ambitions. Assistant Superintendent Jessica Baghian will now manage early education improvement efforts, including the CLASS rating system. Lisa Brochard will continue to oversee the office of early childhood operations, including licensure and eligibility, reporting to chief operating officer Bridget Devlin. Jenna has been an indispensable source of vision and thoughtfulness in her time with our team, and I wish her and her family the best as they work for the children of Virginia.

New: DRC Online Cleanup

DRC will open the Online Cleanup System (OCS) from June 11 to June 15. This is the only opportunity that school systems and schools will have to apply accountability codes to impending zeroes before the new progress index is calculated. The system will include student records from LEAP 2025, EOC, LEAP Connect, and LAA 1. School systems should not wait until the August data certification period to address impending zeroes.

High School Pathways

New: Financial Aid Planning Regional Events

Please share with professional school counselors and/or staff responsible for the implementation of financial aid planning policy in schools.

This year, all students graduating from public high schools are required to submit a state or federal financial aid form, a hardship waiver, or a signed letter from parents who wish not to seek financial aid. The response from Louisiana's students and families has been overwhelmingly positive. Already Louisiana is a national leader, and thousands more students will have their job training or college tuition paid for as a result. But we still have several thousand students left to go before the July 1 priority deadline.

Reminder: 2018-2019 Pupil Progression Plan

Please share with school system supervisors.

Pupil Progression Plans are the policies and guidelines local school systems use to determine whether students will be promoted to the next grade, retained in the current grade, or advanced (or skipped) to higher grades. Pupil Progression Plans also outline the criteria for high school graduation.

Each Local Education Agency (LEA) is required to develop a Pupil Progression Plan for review by the Department. Each agency may have slightly different procedures related to retention, advancement, promotion, and graduation.

As a result of the delayed release of the 2017-2018 Pupil Progression Plan template and related promotion policy updates, school systems may elect to:

- Option 1: Retain the locally approved 2017-2018 Pupil Progression Plan through the 2018-2019 school year; or
- Option 2: Submit an addendum outlining any plan updates for the 2018-2019 school year. Addendums shall be submitted

- Option 2. Submit an addendum outlining any plan updates for the 2018-2019 school year. Addendums shall be submitted no later than August 31.

Special Education

New: 2016-2017 Draft LEA Determinations Packages

Each year, the Department is required to issue LEA Determinations, which assess the performance of school systems on the provision of special education and related services. The draft 2016-2017 LEA Determination packages are now available for review on the FTP site with the name "LEA Code_LEA Name_2016-2017 Draft LEA Determinations." If school systems have questions about the results or wish to seek additional clarification, they must do so by May 25. The Department will issue final results to school systems in early June.

Reminder: IDEA Alternate Assessment Monitoring Results Available

Under ESSA, alternate assessment participation is limited to no more than 1.0 percent of all students. States that exceeded the 1.0 percent cap, including Louisiana, submit a waiver to the US Department of Education, and monitor school systems where more than 1.0 percent of students participated in the alternate assessment. The Department has concluded IDEA alternate assessment

than 1.0 percent of students participated in the alternate assessment. The Department has concluded IDEA alternate assessment monitoring for the 2016-2017 school year.

All monitored school systems now have a notice of closure (no findings) or a notice of action (findings) available on the FTP.

New ESSA and IDEA Amendments

New: ESSA and IDEA Amendments

The U.S. Department of Education recently notified the Department that slight cuts made by Congress to federal funding in Title I, Title II, IDEA 611, and IDEA 619 last fall have been restored. This means that school systems will receive small supplements to their existing FY2017-2018 allocations in eGMS later this spring.

School systems are not required to do a budget amendment unless there is a need to obligate all or a portion of the supplements before June 30. Unexpended funds will automatically roll over into next year's application once the 6/30 Periodic Expense Report (PER) is submitted and approved by the Department.

The final date to submit FY2017-2018 amendments is June 1. Additionally, any school system has an existing amendment returned for changes, please resubmit by June 1.

New: Funding Available for Displaced Students Attending Public and Non-Public Schools

The U.S. Department of Education has announced that applications are available for two of the hurricane and disaster relief programs authorized by the Bipartisan Budget Act of 2018: the Temporary Emergency Impact Aid for Displaced Students (Emergency Impact Aid) Program and the Assistance for Homeless Children and Youth Program.

The **Emergency Impact Aid program** will provide assistance to LEAs and nonpublic schools that have enrolled students displaced during the 2017-2018 school year by Hurricane Harvey, Irma, or Maria or the 2017 California wildfires and the Assistance for **Homeless Children and Youth program** will provide assistance to LEAs to support the needs of homeless students displaced by a covered disaster or emergency.
