Superintendent's Message

Dear Colleagues,

Louisiana was recently approved for the new Pandemic Electronic Benefit Transfer (P-EBT) program, which provides extra help buying groceries for the families who normally receive free and reduced-price meals at school. This includes all families attending a Community Eligibility Provision (CEP) school.

To receive these benefits, families must be notified of the benefits and must complete an application. The Louisiana Department of Education and the Department of Children and Family Services, the agencies jointly overseeing this program, have publicly communicated this information, but the U.S. Department of Agriculture requires schools to also reach out to their eligible families through their regular family communication channels by May 25. School systems are encouraged to utilize [the digital flyer](#), which provides key information and links to the [application portal](#).

The application portal went live on Monday, and despite heavy traffic slowing the site in the morning, nearly 120,000 applications were successfully approved within the first 24 hours. The application portal will remain open until June 8.

In order to ensure success for the remainder of the application period, the state will need your assistance in answering questions from the families of our more than 600,000 eligible children. Among the common questions you might receive:

- "How will I know if I am approved?"
- "How long will it take to receive my card?"
- "Why isn't my child's school listed in the portal?"
- "I think we now qualify for free and reduced price meals at school. Can I complete an application?"
- "Why did I receive an ineligible message?"

The answers to these questions-and more-can be found in [the list of Frequently Asked Questions](#), which will be continually updated.

As you will see in the FAQs, we have advised families to contact their schools and school systems to verify their information if the applicant believes they are eligible but were denied in the application process. The information submitted by parents and the information submitted by school systems must be an exact match.

FASTalk Summer is a simple, accessible, text message-based learning tool to support families with limited access to devices and the internet, as well as those facing language barriers.
- [FASTalk](#) is an easy tool that sends families weekly text messages with curriculum-aligned and standards-aligned learning activities in PK-5 supporting academic, social, and emotional skill development. FASTalk is preloaded with practical tips for parents to support high-quality instructional materials, aligned with ELA Guidebooks, EL, CKLA, Wit & Wisdom, and more. FASTalk supports two-way communication between parents and teachers with automated translation in more than 100+ languages.

- Food assistance, including free and reduced-price school lunches.
- Maternal and child health programs.
- Planning, preparedness, and recovery efforts for national emergencies, including [COVID-19](#).

Self-responses, which can be completed [online](#), by phone, or by mail until October 31, **ensures federal funding to support Louisiana students.**

Update: Waivers for Testing

- To date, the only students who have a waiver from the assessment graduation requirements are graduating seniors who were enrolled at the time of school closing and were in the February 1 enrollment report.
- The current waiver does not apply to students who were not enrolled in school or students who are not yet eligible to graduate.
- In June, the Department will request a change in policy to waive the assessment requirement for a high school assessment-eligible course earned during the regular school year in 2019-2020 (not including summer credit recovery) for students who would have been initial testers in spring 2020. Students who failed a subject test in a prior administration will not be eligible for the waiver of the assessment requirement.

Update: High School Summer Test Administration

- The high school summer test administration schedule is under review. Revised dates will be released as soon as they are final.

Update: ACT

- The Department posted new [K-12 ACT COVID-19 Preventative Measures Guidance](#) to the [Assessment Library](#). The document outlines actions required to protect the students and adults who will participate in the June 2 state ACT administration. While ACT will issue its own guidance, the Department guidelines supersede ACT guidelines. The ACT Administration FAQ, which includes general information about the June 2 administration, has been updated to include a link to this document.
- ACT announced new flexibilities for summer testing and new test-at-home options that will become available in the fall and winter. Information about at-home testing with remote proctoring will be shared as it becomes available.
- ACT National Test Date
 - Although students are only able to register for June 13 and July 18 for national test administrations in the summer, testing sites can request a one-week delay in administration (June 20 and July 25)
- ACT State Administration
 - June 2 standard paper
 - June 2-4 online
 - June 2-8 accommodated window
 - October 6 and October 20 paper-based administration only for students who were juniors in 2019-2020 and were unable to test in March or June. The Department will cover the cost for one administration per student.

Update Cohort Graduation Data Certification

- Cohort graduation data certification will remain open until June 5. Accountability contacts will be notified prior to the official opening date.

Educator Preparation

New: Mentor Provisional Certificates

Beginning in September, every teacher who serves as the mentor of an undergraduate or post-baccalaureate candidate must hold the Mentor Ancillary Certificate or the Provisional Mentor Ancillary Certificate.

In light of COVID-19 school facility closures, BESE has extended the validity of the Provisional Mentor certificate from 12 months to 18 months for individuals who hold this certificate in the 2019-2020 academic year. The additional six months of provisional certification will be applied to [applications](#) submitted by **June 1**. Provisional applications issued after this academic year are valid for 12 months.

- Completed application
- Certificate of training completion, which can be requested from the training provider

Reminder: 2018-2019 Draft LEA Determination Packages

Please share with data managers.

Each year, the Department is required to issue LEA Determinations to assess the performance of school systems on the provision of special education and related services. Please note that LEA Determinations are made at the school system level required by IDEA, while plans to improve struggling schools identified as UIR for students with disabilities is a separate process required by ESSA.

The draft 2018-2019 LEA Determination packages will be available for review May 18 on the FTP site with the name "LEA Code_LEA Name_2018-2019 Draft LEA Determination." Special education leaders should obtain results from their FTP site and review for accuracy. If school systems have questions about the results or wish to seek additional clarification, they must do so by June 1. The Department will issue final results to school systems in mid-June.

Federal Programs

New: Title IV Part A CARES Act Fiscal Waiver Flexibilities

All school systems are encouraged to take advantage of the Title IV Part Cares Act Fiscal Waiver Flexibilities. These fiscal waiver flexibilities allow local school systems to do the following:

1. Target Title IV Part A funds directly to specific needs of school systems without having to adjust the needs assessment.
2. Disregard the content area required percentages to get the maximum fiscal flexibility driven by the school system's Title IV Part A needs. For example, school systems will be allowed to target more funding toward technology infrastructure (i.e. student devices, internet connectivity, etc.) without being limited to the fifteen percent requirement for the Effective Use of Technology content area.

School systems can access the Title IV fiscal flexibilities immediately by amending their 2019-2020 Super App. The areas that will need to be amended will be (1) signing off on the Title IV waiver assurances, (2) noting changes on the Amendment Description page, and (3) adjusting the appropriate domain budget page.

Note: These flexibilities apply only to 2018-2019 and 2019-2020 Title IV Part A funding.

Reminder: School-based Medicaid

Effective for dates of service on or after March 20, 2019, the Centers for Medicare & Medicaid Services has approved Louisiana's State Plan Amendment, which amended the provisions governing school-based medical services covered in the Early and Periodic Screening, Diagnosis and Treatment Program, and school-based behavioral health services.

The expansion will allow for payment for services that are provided to Medicaid eligible students pursuant to an Individual Health Plan (IHP), an Individualized Family Service Plan (IFSP), a Section 504 plan, or services that are otherwise medically necessary. Payment for services provided pursuant to an Individualized Education Program (IEP) will continue to be provided under the expanded program.

The expansion also amended the reimbursement methodology to expand allowable billing providers for direct/therapy and nursing services and added applied behavioral analysis and personal care services.

The Department is in the process of modifying the school-based Medicaid handbook to address these changes.
