New P-EBT Resources Available for Parents and Data Managers

New Toolbox for Data Managers

The new P-EBT Data Managers Toolbox has been established to provide a single secure location where data managers can access files, slide decks, recordings, and additional information about the P-EBT Program. Data Managers who completed the security form have automatically been given access to this toolbox. If additional staff within the LEA needs access to this toolbox, the main P-EBT contact should email EdTech@la.gov to request the additional staff to be added.

New Parent Portal

Today, July 13, DCFS launched a new P-EBT Online Parent Portal that allows parents to view their child's P-EBT case. Information submitted by schools (name, date of birth, local student ID, school name, zip code, benefit amounts, and learning mode) are included within the portal once benefits are processed. A video and instructions on how to register, access, and navigate the portal are available on DCFS's P-

EBT webpage.

New Benefits Issuance Dates

Starting tomorrow, July 14, the second set of P-EBT benefits will be loaded onto cards for eligible students. This set of benefits will cover November 2020 to January 2021. The third set of benefits will be loaded onto cards beginning August 4 and covers February 2021 to May 2021.

Please share with families:

- *Missing issuances: If you don't receive benefits on July 14 and/or August 4, it is possible that your child was not reported as eligible. Please direct any eligibility questions to your school. Please note that benefit amounts are dependent on your child's learning situation on a month-by-month basis and can change if their learning situation changes.*
- *Combined issuances: If you receive your child's P-EBT card after the above dates, it is possible that there will be multiple sets of benefit months already loaded onto the card.*
- *Learning mode changes: If you believe that there is an error in your child's learning mode for a particular month, please contact your child's school or school district to request a review. While there will be a delay, supplemental benefits will be issued if a correction is made.*
- *Address changes: If you need to request an address change, please contact your child's school or school system. While there will be a delay, benefits will be issued once the correction is made.*

DCFS is continuing to distribute P-EBT benefits to eligible children for the 2020-2021 school year as new and updated information is provided by schools and districts.

Mentor Waiver Application

At the March BESE meeting the Board approved an extension of the waiver of policy, contained in Bulletin 746, *Louisiana Standards for State Certification of School Personnel*, and Bulletin 996, *Standards for Approval of Teacher and/or Educational Leader Preparation Programs*, regarding the requirement that all undergraduate residents and post-baccalaureate candidates be placed with mentor teachers holding the ancillary mentor teacher certificate, the ancillary provisional mentor teacher certificate, or the Supervisor of Student Teaching certificate, for the 2021-2022 school year.

Waiver applications will be accepted for the 2021-2022 school year beginning **July 12, 2021**. The LDOE will host office hours to model the application process and answer any questions about completing the 2021-2022 Mentor Waiver Application on **July 14, 2021**. District personnel will be responsible for submitting the application.

P-EBT Communications Update

Updates as of June 29

- Card activation remains one of the main concerns from families and schools pertaining to P-EBT. Below is the information required to activate a child's P-EBT card. All information listed below must be entered correctly. Items b-d must match the data provided by data managers in their upload file. If any of the information below does not match what DCFS has on record, the parent will not be able to activate their card.
 - a. Child's 16-digit card number
 - b. Child's last four digits of their Local Student ID.
 - Enter this four-digit number when prompted to enter the last four digits of the social security number.
 - c. Child's date of birth
 - d. Child's mailing address

The following Q&A is being added to DCFS' FAQ page.

How do I report my child's address change in time to get P-EBT benefits?

All student information and changes must be verified by the child's school. This includes address changes, which must be handled at the school and/or school district level to ensure that the child's card is going to the correct household. If you need to change an address, you must follow your school's or school district's process for submitting and verifying address changes which may include providing proof of residency forms in person at your child's school. Once the school or school district updates the information in the P-EBT system, DCFS will be able to issue benefits and order a P-EBT card for your child. Changing your address will delay the issuance of a new card, but your child will receive their P-EBT benefits.

Note: P-EBT cards cannot be forwarded. If a card has already been issued to a child and sent to an old address, the old card will be returned to the sender and deactivated.
