LEAN Practices School System Spots Still Available

Louisiana, like the nation, faces challenges in recruitment and retention of effective, certified teachers and leaders. In Louisiana, 37% of teachers leave the profession in the first five years of teaching, and 17% of principals leave their role each year. In order for students to have successful outcomes, they need high quality teachers and leaders. Research demonstrates that work-related stress is one of the leading causes of teachers leaving the profession. The LDOE believes that investing in teachers by addressing their concerns is essential in driving school system improvement.
