

## Governor's Emergency Education Relief Fund (GEERF II) Louisiana's K-12 Allocation

## Overview

Congress released the <u>Consolidated Appropriations Act</u>, <u>2021 (CAA)</u> on December 21, 2020. This legislation includes COVID-19 relief specifying <u>appropriations provisions</u> to governors, state and local educational agencies (LEAs), and higher education institutions. The bill also provides for childcare funding for assistance to providers and families and \$3.2 billion for a new Federal Communications Commission broadband fund.

The combined Department of Education and Board of Regents requests for the GEERF II allocation includes advanced broadband access in the state through funding for the establishment of the La Office of Broadband. The chart below reflects the LDOE's priority funding provisions to support students and educators. The initiatives denoted below are in alignment with the LDOE's *Believe to Achieve* priorities and focus areas.

\$2,000,000	ACT Vouchers	To allow current year sophomores & seniors an additional opportunity to test, qualify for Dual Enrollment & TOPS to ensure 10th, 11th, and 12th grade students are on track to a professional career, college degree, or service by providing ACT vouchers	
\$1,000,000	Student Re-engagement	To staff coordinators to re-engage +/- 20,000 absent students in the educational system	
\$1,000,000	Literacy Loss Professional Development	To increase professional learning for educators across the state (open to pre-K-12 & higher ed) to support best practices in academic recovery, phonics, and intervention instruction	
\$1,000,000	Educator Health Coaches	To staff health coaches for B-12 staff for mental, emotional, wellness needs	
\$500,000	Dual Enrollment Portal and Fast Forward Program Evaluation	To support efforts to expand college credits earned by high school students (In partnership with BoR)	
\$350,000	LOSFA Outreach & FAFSA Campaign	To support high school student outreach regarding federal and state financial aid and academic preparation (In partnership with BoR)
