

Policy/Background

On February, 2019, the Board of Elementary and Secondary Education (BESE) updated policy* regarding teacher preparation provider effectiveness data. The policy indicates that the Department will review and report to BESE effectiveness data for each approved approved provider offering mentor teacher or content leader training.

By no later than December 1, 2019, and biannually thereafter, the LDOE will review and report to BESE **effectiveness data** of each approved provider offering mentor teacher or content leader training. Effectiveness data will include **Louisiana mentor teacher assessment series or Louisiana content leader assessment series passage rates** and may include additional information. Based upon these results, BESE may require an improvement plan or may discontinue the provider’s ability to recommend candidates for mentor teacher or content leader certification.

The Louisiana Department of Education has designed a process for collecting, verifying, and reporting Mentor and Content Leader training provider data to BESE.

Step	Description
Initial Enrollment Submission	Training providers complete and submit the Enrollment Form prior to the start of training. Initial Enrollment forms to be submitted to <ul style="list-style-type: none"> • teacherleadertraining@la.gov • support@bloomboard.com Providers using a cohort model will submit once in the Fall, Spring, and Summer.
Data Review	Providers receive assessment completion and facilitator credential reports from Bloomboard to help support in candidate assessment completion.
Enrollment Verification	Training providers verify the following enrollment data: <ul style="list-style-type: none"> • Participant Training Start Date • Participant Training Completion Status • Participant Assessment Series Completion Status • Earned Facilitator credentials
BESE Report	Biannually, BESE receives a report that includes: <ul style="list-style-type: none"> • Participant Assessment Series Completion Rates by Provider <ul style="list-style-type: none"> ○ Completion rates will include the count and percent of participants who completed their assessment series within 12 months of their training start date by provider and pathway
