CONSENT ORDER

This matter was set for a hearing on the State's request for a preliminary injunction to halt the operation of an unlicensed "Child day Care Center" or "Early Learning Center". Prior to the hearing, the parties reached an agreement and now enter into this Consent Order on the following terms:

1. Defendant, Camey Raven consents to the issuance of a preliminary injunction prohibiting her, agents, from operating a child day care facility without a license;
2. In recognition of Camey Raven's cooperation, the State waives its request for statutory fines and penalties so long as Camey Raven complies with this order;
3. Camey Raven does agree to allow the Louisiana Department of Education access to the facility as necessary to conduct site visits in compliance with state and federal guidelines.
4. Camey Raven does agree to provide the Louisiana Department of Education with a roster of all children in her care and identification for all children in her care immediately when requested from Department's staff.

THEREFORE,

IT IS ORDERED, that a preliminary injunction issue, directed to defendant Camey Raven, and enjoining, restraining and prohibiting her, her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without a license; this preliminary injunction to be effective during the pendency of these proceedings;

IT IS FURTHER ORDERED, that the state hereby waives the statutory fines and penalties sought in its petition, contingent upon Defendant's compliance with this Order;

IT IS ALSO ORDERED, that Camey Raven will, consistent with this Order, allow the Louisiana Department of Education access to the facility as necessary to conduct site visits in compliance with state and federal guidelines.


IT IS FURTHER ORDERED, that Camey Raven will, consistent with this Order, provide the Louisiana Department of Education with a roster of all children in her care and identification for all children in her care immediately when requested from Department's staff.


