ORDER

This matter was scheduled to be heard June 28, 2010 on the State's request for a preliminary injunction to block the unlicensed operation of a child day care facility. Prior to hearing the parties reached an agreement and desire that it be made the order of this Court. The Court being satisfied that the consent agreement is justified by law, therefore

IT IS ORDERED that the preliminary injunction issue as requested, without bond, directed to defendants God's Little Blessings Daycare and Learning Center, Inc., Cory Clophus, and Natesha Clophus, and enjoining defendants, together with their officers, agents, employees, representatives, and all others acting at their direction or on their behalf, from operating a child day care without first having obtained a valid, current child day care license from the Department of Social Services;

IT IS FURTHER ORDERED that God's Little Blessings Daycare and Learning Center, Inc., Cory Clophus, and Natesha Clophus, and their agents as detailed above, admit representatives of the Department into any place or facility where children are in care, at all reasonable hours, for purposes of determining the number of children present; and that they admit DSS representatives at all reasonable hours to permit them reasonable investigation of any complaints made concerning them under the Child Day Care Facilities and Child-Placing Agencies Licensing Act.






