IT IS ORDERED by the Court that a permanent injunction shall issue, without bond, enjoining, restraining and prohibiting Martha Jackson, her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without a license.

IT IS FURTHER ORDERED that Martha Jackson is ordered to admit Department of Children and Family Services' inspectors access to her home to conduct inspections during all reasonable dates and hours for the purposes of verifying the number of children present and their relationship to Martha Jackson.
