JUDGMENT

This matter came before the Court for hearing pursuant to a Petition for Injunctive Relief on Friday, March 23, 2012. Present in Court were:

Department of Children and Family Services, Petitioner
Ebony M. Townsend, Attorney for Department of Children and Family Services
Rose Richard, Respondent (Pro Se)

The Court, after considering the applicable law, testimony of witnesses and evidence being in favor of Petitioner, the Court rendered judgment as follows, to wit:

IT IS ORDERED by the Court that a permanent injunction shall issue, without bond, enjoining, restraining and prohibiting Rose Richard and Glynn Richard, their officers, agents, employees, representatives, and all others acting at their direction or on her behalf, from operating a child day care facility without a license.

IT IS FURTHER ORDERED that Rose Richard is ordered to admit Department of Children and Family Services' inspectors access to her home to conduct inspections during all reasonable dates and hours for the purposes of verifying the number of children present and their relationship to Rose Richard.

IT IS FURTHER ORDERED that pursuant to LSA-R.S. §46:1421, Rose Richard is fined Seventy-Five Dollars (\$75.00) for operating an unlicensed day care facility on February 10, 2012, which fine is payable within thirty (30) days of March 23, 2012 to the Department of Children and Family Services.
