CONSENT ORDER

This matter was set for hearing for January 28, 2011 on the Department of Children and Family Services ("Department")'s request for a preliminary injunction. Prior to hearing the parties reached a consent agreement and desired that it be made the judgment of this court. The Court being satisfied that the Order is entered into freely and voluntarily by both parties, appearing through Counsel, and being satisfied that the Order is in accord with the law and evidence, therefore

IT IS AGREED, AND SO ORDERED, that a preliminary injunction issue, without bond, directed to defendant MONA ADAMS, and enjoining defendant, together with her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without a valid, current child day care license;


IT IS FURTHER AGREED, AND SO ORDERED, that defendant Mona Adams has operated without a license for a period of ten (10) days, and is hereby assessed fines in accordance with statute of \$100.00 (ONE HUNDRED DOLLARS) per day for each day of unlicensed operation, or a total of \$1,000.00 (ONE THOUSAND DOLLARS).

IT IS FURTHER AGREED, AND SO ORDERED, that the above statutory fine be and hereby is SUSPENDED, solely upon fulfillment of the condition that defendant Mona Adams comply with all terms of this Consent Order now and in the future.

IT IS FURTHER AGREED, AND SO ORDERED, that defendant Mona Adams cooperate fully with inspectors from the Department of Children and Family Services in verifying compliance with the terms of this Order, including but not limited to admitting said inspectors during all reasonable dates and hours

for the purposes of verifying the number of children present and their relationship  
to defendant.
