

**ORDER**

This matter came on for hearing the twenty-third day of May, 2011 on the State's request for a preliminary injunction to block the unlicensed operation of a child day care facility. Present were Anthony Caruso for the Department of Children and Family Services and defendant Rosary Lynn Turner. After considering the verified petition, the testimony of the State's witness, and the admissions of defendant, and finding that the State has made out a *prima facie* case that it is entitled to the relief sought, therefore

IT IS ORDERED that a preliminary injunction issue, without bond, directed to defendant Rosary Lynn Turner, and enjoining, restraining, and prohibiting defendant, together with her officers, agents, employees, representatives, and all others acting at her direction or on her behalf, from operating a child day care facility without first having obtained a valid, current license from the Department of Children and Family Services, legal successor agency to the Department of Social Services.
