# Mentor Workgroup Recommendations

Beginning in September 2020, every teacher who serves as the Mentor of an undergraduate or post-baccalaureate candidate must hold the Mentor Ancillary Certificate or the Provisional Mentor Ancillary Certificate.

In August 2020 BESE allowed a waiver of the Mentor credential for the 2020-2021 school year. This was prompted by a shortage of credentialed Mentor teachers willing to host residents specifically in certain content areas such as Music, Physical Education, as well as others 6-12 content areas. In September 2020 the Mentor workgroup was created to examine the issue of Mentor shortages. The purpose of the Mentor teacher workgroup was to examine what steps might be needed in order to ensure a robust pool of effective mentor teachers in all content areas and grade bands.

The workgroup has several recommendations to achieve the goal of increasing the pool of effective mentors. They include:

- 1. Honoring Previous Training and Experience
- 2. Removing the Content- Specific Assessments
- 3. Creating a Mentor Support Guide
- 4. Creating an Add-On Mentor Endorsement
- 5. Exploring Mentor Assessment Content and Scoring
- 6. Granting a one year extension for those currently holding Provisional Mentor Certificate

These recommendations will be shared with BESE members at the March 2021 meeting. Potential policy changes would then be brought to the board in April.

# Mentor and Content Leader Training Providers

**Program Approval:** Applications are under review for programs seeking approval in April 2021 to offer Mentor or Content Leader training pathways. Two new programs applied to offer Mentor training and nine applied to offer Content Leader training. More information about the application requirements and process can be found in the Mentor Teacher and Content Leader Training Applicant Guides.

**Data Collection and Verification:** In October 2021, BESE will receive effectiveness data of each approved provider offering Mentor or Content Leader training. Effectiveness data will include Louisiana Mentor assessment series or Louisiana Content Leader assessment series passage rates and active

training facilitator credentials. The <u>process for data collection and verification</u> can be found in the Training Provider Section of the Mentor Teacher and Content Leader Library.

### Teacher Leader Summit: The Virtual Series

To maximize the delivery of content and educator development, The Teacher Leader Summit: The Virtual Series will take place from June 1-11, and sessions will be accessed remotely. The format will be similar to the Virtual Series offered during spring 2020.

- There will be a max overall registration limit of 8,000.
- The Department is not allocating seats. Registration will be on a first-come, first-served basis.
- Paid ticket holders of the Teacher Leader Summit in-person event will receive an access code allowing them to register for and participate in the Virtual Series at no additional cost.
  - Each code will be one-time use and must be used only by the original ticket holder.
     Codes are not transferable.

#### **Certification Updates**

Educational Testing Services (ETS) recently revised the Middle School Science exam and will discontinue the existing titles. The current exam (5440) will not be available after **March 31**, **of 2022**.

The new PRAXIS Middle School Science (5442) exam has been redesigned to reflect expectations for teachers to be ready to engage, instruct, and support 21st century students. The new exam is aligned to Next Generation Science Standards (NGSS) and National Science Teacher Association (NSTA) standards which incorporate the Tasks of Teaching Science and the Science and Engineering Practices, in addition to gathering input from national advisory committees and over 1000 educators. In March, BESE will consider adopting this new exam (5442) with a passing score of 152.

The Practitioner License (PL1 and 2/3) applications have been updated. Please download and use the current application. The new application will be required **April 1, 2021**.

**National Accreditation** is now accepted as a form of institutional accreditation for certification purposes. If an accrediting association is recognized federally by the U.S. Department of Education (USDE), the Certification Office will accept any degree(s) or coursework earned. All degrees and coursework must be submitted on **official transcripts**.

In December, BESE approved (via emergency rule) to extend the effective date of the Praxis Core Academic Skills for Educators: **5712**, **5722**, **5732** exams to **December 31**, **2020**.

For exams taken and passed after December 31, 2020, Praxis Core 5713, 5723, 5733 will be the only core exams accepted.

# TEACHER PREPARATION QUALITY RATING SYSTEM

### **Teacher Preparation Performance Profiles**

The 2018-2019 and 2019-2020 teacher preparation informational performance profiles were publicly released on Louisiana Teacher Prep during the first week in March. BESE received an update report regarding the Teacher Preparation Quality Rating System on March 9. The Department will provide an overview of key discussion points from that meeting during the March Believe and Prepare webinar.

# TEACHER PREPARATION PROGRAM APPROVAL

## **2021 Program Approval Applications**

Teacher, early childhood ancillary certificate program, educational leader proposals for initial approval, and mentor and content leader training proposals are accepted and considered by BESE twice per year. Proposals that meet all initial submission requirements will be evaluated by a panel of reviewers to ensure proposals meet policy requirements.

Preparation providers seeking approval to offer new programs must first submit a Notice of Intent (NOI). The Department will send a link to the application following receipt of the NOI. The deadlines to submit notices of intent and applications are highlighted in the chart below. Note that providers may submit NOIs after the deadline. Applications must be received by the below deadlines in order for them to be reviewed during the below review cycles.
