# 3rd Graders Show Strong English/Language Gains









# **Steady Decline in Math (again)**







# **Professional Learning Partner Guide**




# **Science Sample Course Outline**




# **Geaux Teach Scholarship Program**

Act 463 of the 2022 Regular Session of the Louisiana Legislature established the Geaux Teach Program, which provides scholarships to students who are enrolled in teacher preparation programs at the state's postsecondary institutions that are approved by the Board of Elementary and Secondary Education (BESE).

Students may receive up to \$5,000 annually to cover the cost of tuition fees, textbooks, and instructional materials required for enrollment. The <a href="Geaux Teach Bulletin">Geaux Teach Bulletin</a> includes allocations for each eligible postsecondary school and provider.



# **Associate Teacher Program**

Under <u>ACT No. 99</u> of the 2023 Regular Legislative Session, the State of Louisiana now allows schools to hire candidates holding an associate's degree who are enrolled in a teacher education preparation program to serve as a teacher of record. The authorization for the associate teacher to be a teacher of record is issued by the LEA, not the LDOE.

The LDOE has released a <u>guidance</u> document for our teacher preparation providers that can be found in the <u>Preparation Library</u>.

# **Numeracy Competencies**

Act 347 of the 2023 Regular Session, states that BESE shall revise teacher certification requirements and the requirements of teacher education programs to require instruction on foundational numeracy skills standards for candidates seeking certification to teach students no later than December 31, 2023.

Focus group participants were selected by completing a survey that was posted in various newsletters and calls.







# **Numeracy Competencies Summary**

The following trends were noted in the focus group meetings.

- Need for defining key words (i.e., numeracy, foundational numeracy, HQIM, fluency, blending, foundational mathematics)
- Replacing word choices (i.e., acceleration vs remediation and unfinished learning vs gaps)
- The direct connection to the legislation

The following questions were also noted as trends.

- Will higher education need to change their courses?
- How are the competencies connected to the training in Act 260?
- How will the competencies tie into the new evaluation rubric?

The competencies and updates to policy will be brought to BESE in December.







# **Pathways to Teaching Report**

House Resolution 190 of the 2023 Regular Legislative Session urged and requested the Louisiana Department of Education (LDOE), in consultation with the State Board of Elementary Education (BESE), to study all pathways for a graduate of a postsecondary education institution to enter into the teaching profession and to make recommendations for removing barriers to certification and promoting consistency in certification and permit requirements.

The resolution requested that LDOE, inconsulation with BESE, pursue consultation with deans and directors of teacher preparation programs, at both universities and private providers, to determine how candidates are impacted by the certification requirements implemented by LDOE and promulgated by BESE.





# **Pathways to Teaching Survey**

Focus groups were held with preparation providers in September to gather information for the report.

LDOE would like to invite Educator Preparation Providers to complete a <u>survey</u> via Jotform on the available pathways to enter the teaching profession. The survey will cover topics such as financial barriers for candidates, certification requirements, and the consistency between each pathway to certification.

#### **Educator Evaluation Pilot**

Following an RFP process, the Department has contracted with the National Institute for Excellence in Teaching (NIET) to assist with reimagining the Louisiana evaluation system based on research and best practice, along with developing resources to support professional learning. This transition to an improved system will span over the course of three years.

Evaluation components and process for all educators and school site leaders are currently being piloted in seventeen school systems across Louisiana.






# **Evaluation Pilot Components and Process: Teachers**

The following components and processes are being piloted with educators:

- Louisiana Educator Rubric for observation
- Three formal observations
  - First observation within first 45 days of school
  - One announced, two unannounced
  - Multiple observers
- Professionalism Survey completed with each observation
- Self-assessment of each formal observation
- Follow-up coaching cycles based on refinement areas
- Student surveys to gather additional information





During the 2024-2025 school year, all school systems will participate in an Evaluation Learning Year, prior to the 2025-2026 full implementation.






### **New Applications**

In response to the newly adopted policy, **all** applications were updated on or before **October 1, 2023**.

- Beginning November 1, 2023, all applications are required to be the October 1,
   2023 version for processing.
- Beginning November 1, 2023, applications will no longer be placed on hold waiting for evidence of payment. Any applications not including evidence of payment and/or accurate payment amount will be closed unprocessed.
- Beginning November 1, 2023, we will no longer accept corrected application pages to modify an incorrect request as a 'Feedback Follow-up.'





## **Residency Restrictions**

Revisions were adopted regarding teacher candidates serving as a resident teacher remove the limitation of days that can be served as a substitute teacher, provided such service does not impede residency performance or ability to successfully complete the preparation program.

Service as a **long-term substitute** would likely impede the residency requirements as outlined in Bulletin 996 and is **not recommended**. Partnership and communication with the school system in which a resident is placed is essential to the success of the residency.

Part of the completion of the preparation program is the percentage in which they must serve in the residency. Service as a substitute teacher **does not** count towards the residency hours or residency activities.







## **Special Education Exams**

ETS is redesigning and retiring existing Special Education Exams.

- Special Education: Core Knowledge and Applications (5354) and Special Education: Core Knowledge and Mild to Moderate Applications (5543) is being replaced with Special Education: Foundational Knowledge (5355), passing score of 145
- Special Education: Core Knowledge and Severe to Profound Applications (5545) is being replaced with Special Education: Severe to Profound (5547), passing score of 156

The usual one-year overlap where either exam is accepted is applicable.

These exam changes affect **Deaf and Hard of Hearing, Mild to Moderate, Significant Disabilities, and Visual Impairments/Blind** areas of certification.







### **GPA Flexibility**

Conditional admittance into a teacher preparation program is now available to candidates with less than a **2.2 undergraduate GPA**.

**Conditional admittance** and the use of the flexible GPA option must be indicated on all PL applications for candidates with **less than a 2.2 GPA**.

- If the program awards credit hours, the applicant must obtain a 3.0 GPA for the first 12 semester hours and must complete with a 2.5 GPA.
- If the program does not award credit hours, the applicant must demonstrate mastery of competencies as required by the program and the school system in which clinical practice is completed.



### **Practitioner's License (PL) Application**

- Passing Content Exam scores (electronically or official score reports)
  - Program admission date cannot precede the passage of content exams
- Official transcripts indicating minimum of an undergraduate degree with 2.20 cumulative GPA at the time the degree was awarded/conferred
  - GPA flexibility permitted no interview required
  - No separate GPA flexibility form checkbox, attestation and initials required
- Intent to employ (area of assignment) and area of certification must align




## **Literacy Policy**

In alignment with 2021 Legislation, last year, literacy policy updates were approved regarding the Science of Reading competencies. Policy updates included:

- Science of Reading competencies included for all literacy coursework
- Teacher Preparation Programs must align literacy coursework
  - Beginning with the 2024-2025 school year, program completers are required to have the updated literacy foundations/Science of Reading-aligned coursework
  - Mild/Moderate Special Education areas now require 9 semester hours of literacy coursework

These updates are applicable to both **initial and add-on requirements** beginning **September 1, 2024.** 





## **Literacy Exam Update**

In 2022, the state legislature passed <u>Act No. 448</u>, which requires kindergarten through third-grade teachers seeking initial licensure to pass an examination of the teaching of reading that is scientifically researched and evidence-based.

Policy reads: Beginning January 1, 2024, as required per R.S. 17:7.1(A)(1), an applicant applying for initial certification to teach kindergarten through third grade shall pass the BESE-approved Teaching of Reading: Elementary or Teaching of Reading: Elementary Subtest exam in accordance with §303 of this part. Candidates already enrolled in the year-long residency and holding either the PL or R prior to January 1, 2025 are not subject to this provision.

The LDOE will be proposing a recommended passing score of the newly designed Louisiana Elementary Multiple Subjects exam at BESE in **January**.










### **Initial Certification Requirements**

Please ensure all students are following your BESE-approved teacher preparation program. To receive initial certification, program completion requirements should include:

- Year-long residency
- Holding a pre-service certificate
  - Traditional (undergrad) Resident (R) certificate
  - Alt-Cert (post-baccalaureate)
    - MAT R or PL
    - Cert-Only R or PL
    - Practitioner Teacher Program PL
- Mentoring by a certified mentor teacher
- Literacy hours
- GPA



# **Mentor/Content Leader**



### **Mentor and Resident Funding**

In the 2023-2024 academic year, the data collection for Mentor compensation will take place using a similar process to what was used in 2022-2023. Those unable to join the Fall 2023 Mentor and Resident Funding call to review the funding eligibility and process should review the posted <a href="PowerPoint deck">PowerPoint deck</a>.

School systems must submit all required data no later than **October 26 at 5 p.m.** in EdLink. The data snapshot will be taken on **October 27**. All certificates required (Practitioner License, Resident license, Mentor credential or waiver) must be issued by **October 1** in order to be eligible for funding.






### **Funding Overview**

In the 2023-2024 academic year, the data collection for the mentor compensation will take place using a similar process to what was used in 2022-2023.

- Mentors who support year-long undergraduate residents and post-baccalaureate candidates (first year PLs) will receive \$2,000.
- Through the teacher pay increase approved by the Legislature in 2019-20 (\$1000), 2021-22 (\$800), and 2022-23 (\$1,500) the Department will allocate funds for LEAs to pay \$3,300 to yearlong undergraduate residents who hold a resident certificate and are completing their residency in a public school.
- This funding is allocated to school systems who host residents. School systems should pay Mentors and residents directly.
- Funding will be provided through the Minimum Foundation Program (MFP)
  formula via the certificated pay raise calculation.





### **Mentor Waiver**

In April 2023 BESE approved a full waiver of the mentor credential for the 2023-2024 school year. Just like previous years the mentor waiver will be granted on a case-by-case basis through the application process established by the LDOE and at no cost to the applicant, school system, or teacher preparation provider.

The <u>2023-2024 Mentor Credential Waiver Application</u> opened in July. Refer to the <u>Mentor Waiver Application Guide</u> for details on completing this year's application.

The 2023-2024 Mentor waiver application portal will remain open until June 8, 2024.



# 2023 Mentor and Content Leader Training Provider Effectiveness Report






# High School Science Resources for Learning Recovery

What? Teacher professional learning and student materials to support implementation of OpenSciEd high school units in Biology, Chemistry, and Physics.

Why? To broaden student access to high-quality science instruction in these courses with the goal of addressing learning loss.

When? Professional learning in January with materials supplied in time for spring implementation.





### **OpenSciEd for High School**

Development of the high school materials began in 2021 and Louisiana teachers participated in the two year field test which concluded last spring.

University of Colorado at Boulder, the developers for another Louisiana pilot, inquiryHub Biology, led the development for the OpenSciEd materials.

Guides for piloting all three course are currently available on the K-12 Science Resources website.









# Act 517 Compliance Reviews Status Report

The Department is reviewing currently posted Tier 1 and 2 ELA curricula that includes foundational skills for Act 517 (2022) compliance. Upon completion, a cover page is added to the posted review noting the impact of the review for compliance.

The Act 517 Compliance Reviews Status Report lists the status of all Act 517 compliance reviews, including reviews that have been completed, titles that are under review or ready for review, and titles that have not been reviewed for Act 517 compliance.

### Act 517 Compliance Reviews Status Report

On June 21, 2022, Louisiana lawmakers signed <u>Act 512</u> into law to ensure that all textbooks and instructional materials used to teach students to read are high-quality flight aligned to state content standards, and based on literacy strategies that are scientifically researched with protein state in teaching phonological awareness, letter formation, phonics, decoding, fluency, vocabulary, and comprehension. As part of the Louisiana Department of Education's support for a seamless transition to textbooks and instructional materials that are based on scientifically researched literacy strategies, the LDOE identified the criterion and indicators used to review instructional materials that were impacted as a resort of this legislation.

The LDOC reached out to publishers with posted Tier 1 or Tier 2 state reviews that include foundational skills and requested access to their instructional materia to examine for the following changes in alignment resulting from Act 517:

- Instructional materials and embedded assessments do not require or encourage the three-cueing system model of reading (students gaining meaning from print through Semantic, Syntactic, or Grapho-phonic cues) in reading instruction;
  - Instructional materials and embedded assessments do not require or encourage visual memory as the primary basis for word recognition; and/or

### **Reinstatement of Lifetime Certificates**

Lifetime certificates **lapse for disuse** if the educator does not serve as a teacher for five consecutive years without being regularly employed for at least one semester, or 90 consecutive days, as a teacher.

Lapsed certificates may be **reinstated for a five-year** period at the request of an employing school system.

At least three effective ratings during the five-year reactivation period must be earned to reinstate lifetime validity.




